## Old Business:

- -Official thank you to those who helped on the following projects over the past year:

## Ongoing Issues:

- -All dogs need to be on leash at all times
- -Guests need to be accompanied at all times by their host
- -Members leaving vehicles parked blocking boat launch. New signage placed.

## Finance:

- -Gerry Ensminger stepped down from position, Katie Gallagher has been filling the position interim.
  - -Brandon Thompson Motioned Katie be new permanent treasurer, Sheri Hendon seconded, group approved unanimously. Katie Gallagher is new Treasurer.
- -Property Taxes up this year approx. \$75 to \$2313.53. First Half paid.
- -Annual Park Liability Insurance Premium up to \$1377. Renewal in May.
- -Current General Balance as of today: \$2828.46

## **New Business:**

- -Brandon proposed the timber cleanup project in the SE corner resume this fall.
  - -Will gather volunteers when time gets closer.
- -Cleanup Date Chosen: Saturday May 3 at 10am
  - -Volunteers requested to help afterwards to hang the chain link fencing along the highway.
- -Discussion and motion to rebuild the general use dock as funds allow and open up the ability for homeowners to reserve a temporary day spot for \$20/day or \$50/weekend. Beaching at the posts for the day still free. The intent of this is to provide alternative options to mooring for those who only use their boat a handful of

weekends per year. Reserved for A-member homeowners or their family only (no non-family guest boats)

- -Brandon Thompson Motioned, Sheri Hendon seconded the motion, members unanimously approved.
- -Garry Creel Suggested placing a locking gate at the foot entrance of the park. Members expressed that currently the convenience of no gate for ATV use, strollers, dog-walking, performing maintenance outweigh the cons of occasionally having to kick trespassers (3-4 per year) out.
- -Earl Pickering proposed adding wi-fi security cameras to the two entrances, boat launch, and mooring dock (total of four).

Brandon Thompson motioned for park to allocate up to \$600 to cover 4 solar wifi cams and access point (no ongoing subscriptions/service required). Sheri Hendon seconded the motion. All members present approved unanimously.
