A SPECIAL MESSAGE FROM NATIONAL COMMANDER GALBRAITH AND CONGRESSMAN TEAGUE

Every American and particularly all American Legionnaires should be made aware of the following letter to the National Commander and through him to you from Congressman Olin E. Teague. Chairman of the House Committee on Veterans' Affairs:

Dear Commander:

Our country is in a horrible and dirty war in Vietnam. The American men fighting there deserve the full support of the American people. They are not receiving it.

Our Government has made a decision. Regardless of whether we personally

FIRST IN THE COUNTY

At the November County Legion meeting Blanchard again found itself as leading all thirty Posts with memberships when the roll was called by County Membership Chairman Jim Farrell.

Make certain you have checked their separation papers to assure they meet the requirements of Legion membership", advises Chairman Bill.

Last month a half dozen new Blanchard Legionnaires went through the ceremony of induction into the American Legion. They were sworn in by Commander Sid Kaplan with County Vice Commander Al Woehrle of our Post officiating as the installing officer. The new Legionnaires are Ken Burns, Dick Davis, Henry Ristau, Bernard Skaskiw, Donald Smith and Bruce Swayze.

think it is wrong, it is our Government's decision; and every American should support our fighting men who are carrying out this commitment.

The veterans of other wars are the natural leaders in building the needed support. I know that the American Legion has already done much to bolster public support for our Vietnam commitment, but I am calling upon you now to renew and reemphasize those efforts.

I have been to Vietnam three times. and I visited the Infantry, Artillery, the Marines along the DMZ line, hospitals, hospital ships, the Air Force and the aircraft carrier, the USS Bon Homme Richard. In a recent eight-month period twenty-six thousand of our men in Vietnam have extended their tours. They believe in what they are doing.

Every honest dissenter, dishonest dissenter, draftcard burner, peacenik and draft-dodger is prolonging the war; and these efforts are organized. They are encouraging our enemy to continue to kill more Americans, as clearly established by the excerpts from the Communist press and radio set forth in the attachment to this letter.

I believe we should use whatever force is necessary to get this war over with and bring our men home. We must give them our full support.

If you agree with me, won't you make your views known in every local form, in wires and letters to your elected representatives and the President so they will know our men fighting in Vietnam have your support. I would appreciate hearing from you.

FIRING LINE

Most members of the American Legion are acquainted only with The American Legion Magazine which as members they receive monthly. Its subscription is automatic with the payment of Post dues.

In addition to this informative and colorful publication the American Legion has several other monthly papers, some of which have subscription rates, all very informative. Among these are FIRING LINE, ADVANCE, and LEGISLATIVE BULLETIN

ADVANCE is issued primarily as a bulletin from National Headquarters to Post Commanders. It serves to guide the local heads of the American Legion on Legion policies and principles.

The FIRING LINE is also distributed to the Post Commanders. In addition it is available at a \$3.00 annual subscription rate with special rates for bulk quantities. Our Americanism Chairman, Charlie O'Hara (Past Commander) enjoys a subscription to this important Legion paper issued through the National Americanism Commission.

In the light of recent national developments Chairman O'Hara brings to our attention this recent guideline from the FIRING LINE.

ATTENTION ALL POSTS

From time to time, other organizations contact American Legion Posts, requesting support of that organization's programs. Some organizations solicit The American Legion's assistance in securing signatures to petitions. Post officers are cautioned that, whenever contacted by other organizations, the position of such organization, or the securing of signatures on petitions, should not be supported unless a check is made to see what the mandated position of The American Legion is on such a subject. If The American Legion does not have a position on a subject, a post should not lend its support to another organization's position in the form of an endorsement by The American Legion.

The above statement is based upon the authority embodied in Resolution No. 6 adopted by the National Executive Committee of The American Legion in October, 1952, and the resolving clause of that Resolution reads as follows:

"RESOLVED, by the National Executive Committee of The American Legion in meeting assembled in Indianapolis, Indiana, October 10-12, 1952, that The American Legion shall not be a member of, or affiliated with any organization, committee, association, council, or group whereby The American Legion might be committed to a policy contrary to that adopted by The American Legion."
