POST OKAYS PLANS

At one of the best attended meetings in recent years, last month, approval was voted unanimously to go ahead with plans to undertake improvements at the Post. More than a tenth of the Post membership was present. That sets some kind of a record. A report and recommendation of the Board of Directors for renovation of the building and its facilities was read by the Board Chairman, Harold Barkhuff. The move to accept the report was made by Gerald E. Rowley and quickly seconded. After extended discussion on questions of financing and other refinements of the report the move to accept the report was approved without objection.

This action was followed by a move to authorize the Board of Directors to approve expenditures up to twenty-eight thousand dollars to carry out the recommendations of the Board of Directors for improvements of our Post Building.

With the action by the Post membership completed, arrangements were made for Weber Brothers Construction Company to go ahead with the work. Bill Weber, like the other bidding contractors, are members of the Post. The Weber Co. came in with the lowest bid.

Approval by the State Liquor Authority is being awaited before the alteration work can go forward.

For this major action in the advance of Blanchard Post recognition is due the entire Board of Directors. Those members with Harold Barkhuff are Al Greenwood, Dick Lenseth, Given Hynds, Bill Segur, George Wenger, Herb Drew, Bill Johnston, Bud Mosmen, Commander Fryer and Finance Officer Bill Hayes.

This is the Report presented by the Board of Directors:

Report and Recommendation of The Board of Directors for Renovation of Building and Facilities.

For several months your Board of Directors has been studying plans for the renovation of our building coupled with requests from many members of the Post for improving our grill room facilities.

Foremost in the plans was replacement of the stairs from the parking lot to the basement and the stairs going down from the main floor. Both of these are definite hazards. Many people have fallen and been injured. Fortunately we have not been confronted with law suits.

Many plans have been considered, from doing only the necessary work to enlarging the entire building and even to the construction of a new building. Enlargement of the building was estimated to cost in the neighborhood of \$65,000 which was not considered economically sound. New construction would run from \$100,000 to \$125,000 or perhaps more.

It was the consensus of the Board that we proceed on a moderate plan, so arranged that if considered feasible at a future date, additions can be made. The plan approved by your Directors has been prepared by Mr. Charles Schade, architect. It will provide:

1. — a new modern rear entrance at ground level with stairs to the basement and to the main floor, and provision for cloak rooms.
2. — removal of the present stairs from the main floor to the basement and replaced with new ones which will be wider and not so steep.
3. — install drainage along the west wall of the basement to prevent flooding of the floor during wet periods.
4. — relocation of bar and elimination of present unsightly old kitchen.
5. — removal of the present partition of the old boiler room and after renovation of the area, install a new bar with all modern facilities.
6. — in a part of present old kitchen area provide space for a ladies room.

In the course of this work much expense is involved in moving partitions, installing new plumbing, slightly modifying our present heating system to provide heat in the new entrance and install new lighting for the bar and entrance. It will require dismantling the fire place in the squad room which is supported by uprights in the old boiler room. Bids have been received from several contractors, all members of the Post, covering the work. Low bids are as follows:

ODE TO A DOUGH - BOY

Veterans Day, I am sure, will bring back to many Americans young and old, memories of wars in which we fought, long ago, and not so long ago.

My thoughts go back to a day in November 1918, the eleventh to be exact, when word that an armistice had been signed, came to us, at our gun pits, in Death Valley, Verdun, France. Subsequent orders were to move our 75's to Bois de Thierville, a small town on the outskirts of Verdun. From there the Regiment moved southward, staging nightly at towns along the route. The Meuse-Argonne Offensive had badly depleted our ranks of men and animals. Heroes without medals, those fine horses and mules who lay dead under the cold November rain, their stiffened carcasses' victim of shell fire and exhaustion. Suffering had been their common lot, the clinging mud, the sodden ground at picket lines, the cold nights, the lack of fodder, shell fire and air raids, they had endured, to the very end.

On December 20th, we eventually reached our destination, one of many on our long way home: Varennes-sur-Amance, and here we were billeted until the third week in January. What a relief to know that this war was over! Men who, a few weeks before had been returning from the front lines colorless gray as the lice in their shirts, were living again, ruddy of face, and with hopefulness in their eyes.

General orders had shattered our hopes of being home for Christmas, so we settled down to make the best of it;

however, this was not to be an uneventful holiday. President Wilson, in France for a Peace Conference, had expressed a desire to review the 26th Division, and have dinner with the men.

The original plan was for the President to drive along a designated route inspecting the different units at attention. After the inspection, he was to proceed to Montigny-le-Roi for dinner with men of the 26th Division.

For those units who stood at attention, the less said the better. They were not reviewed, and after several hours of a cold bleak day, they were dismissed.

President Wilson did arrive at Montigny-le-Roi with his entourage, and I am sure little did he realize, the amount of effort and preparation his arrival had meant to the Division.

Food was scarce; our Mess Sergeants had combed the countryside for the makings of a meal to set before a President. What a meal it was, for I was there, and I have before me the original menu. Everyday fare to many of us now, but then sheer luxury:

And although this event took place forty-four years ago, I do not think that any of us who were there will forget it.

I am sure that those who watched the President eat his meal in silence will never know if he enjoyed his dinner, for when he had finished, he arose from the table, and without a nod, or a thank you, left the hall, and so ended the memory of another Veterans Day.

RESOLUTIONS ADOPTED AT NEW YORK DEPARTMENT CONVENTION

Among the 69 Resolutions adopted at the 44th Annual Department Convention, the following are summarized for the information of our Post members who may be interested in them:

Increase in Per Capita Tax — Resolved that each member of The American Legion, Department of New York pay an additional sum of 25 cents per capita tax so that the Department of New York American Legion may meet its current operating expenses and that the Department Constitution be amended to reflect this increase.

Veterans Pensions — Resolving the utmost support to the 2 Legion sponsored Bills — HR 886 and HR 2237 now pending in Congress, which, if enacted, will effectively liberalize present pension laws benefiting all veterans as well as their widows and orphans.

Cemetery listing — Instructing the Department Commander to appoint a special committee to make a survey of existing conditions regarding the cemeteries in the State of New York.

Chiropractic Service — Supporting legislation so that a person entitled to receive care by or through the VA shall if he so elects have the right of receiving chiropractic care and the VA shall make available the services of qualified chiropractors on an out-patient basis.

Korean Bonus — Directing the Department Commander to appoint a special committee to coordinate the efforts to enlist support for a Korean Bonus in New York State and urging the Legislature of the State of New York to take appropriate Legislative action.

Time off for attending conventions — Recommending Legislative or Executive action to afford Veteran Civil Service employees time off with pay to attend Conventions as officially accredited representatives in addition to all other leave with pay.

Veterans Homes — Urging the National Organization to prepare a bill for Congressional Legislation reactivating various veterans' homes throughout the country which have been closed.

Petitioning the State Administration to make provision in the State budget for placing an American Flag in each classroom in each State juvenile corrective institution.

ROTC in High Schools — Urging the Military Affairs Commission to consider the feasibility of instituting an ROTC program in the High Schools.

Retirement Benefits — Favoring legislation that all war veterans in the employ of the state, county and municipal governments be granted credit for retirement benefits in the respective retirement systems for the period served in the armed forces of the United States in time of war.

Prayer in Schools — Urging the Department Commander to immediately request the Department Americanism Chairman to formulate a procedure whereby all posts of The American Legion will forthwith take the initiative in encouraging parents and school boards to establish a procedure for prayer in the schools which is not prohibited in the Regent Prayer decision or prohibited by the 1st Amendment of the Constitution.
