POST BY-LAWS CHANGES COMING UP FOR VOTE

The committee appointed by Commander Joe Cannizzaro to review the Post's Constitution and By-Laws has

completed its work.

Chairman Charles J. O'Hara reports the committee is prepared to submit to the Post recommendations for changes. These changes, Commander Joe says, can be presented to the membership for a vote at the mid-December meeting.

There are four specific changes being offered. Of these, one relating to Viet Nam period veterans, comes to us from National Headquarters through our Department Commander.

Commander's Notice

"In keeping with paragraph 2 of Article VII of the Post Constitution and Article XVI of the By-Laws," announces Commander Cannizzaro, "this serves as a notice to all members of Nathaniel Adams Blanchard Post No. 1040 of the American Legion, Department of New York, Inc., that on this first day of December, 1966, I have designated the regular Post meeting to be held on January 16, 1967 at 8:30 p.m., at the Post headquarters, the time and place at which to submit for a vote by the membership proposed changes in the Constitution and By-Laws.

Viet Nam Vets

The changes are recommended by the committee appointed October 3:

Membership as described in Article III, paragraph 1 of the Constitution to be revised to include, in keeping with the recent American Legion action and legislated federally, Viet Nam wartime

For this change the following is to be inserted on the eighth line after the words "both dates inclusive;" August 5, 1964 until the end of hostilities as determined by the Government of the United States.

Paragraph 4 of Article V to have the last line changed to read "World War II, Korean War or the Viet Nam War period".

Directors Term

An issue which had considerable debate in the committee has to do with the term of office of the Board of Directors. This body of officers is concerned with the maintenance of the Post building and the financial status and operation of the

Vice Commander-Membership Chairman Tom Patterson reports the first Viet Nam War veteran to become a Post member is Kenneth J. Simpson, Delmar. He is sponsored by his father, Kenneth N. Simpson.

Young Ken was recently discharged from the U.S. Navy after completing two years service which ended with duty in the Viet Nam War Zone. Ken was on the Committee That Cares list. The American Legion, with Congressional action signed by President Johnson two months ago, authorized the acceptance of honorably discharged members of the Armed Forces who have been on active duty since the Bay of Tonkin naval engagement on August 5, 1964.

It is planned to formally swear young Ken into the American Legion at our Post at the December 5 meeting.

Chairman Patterson also reports as of the mid-November meeting, Blanchard Post was about two-thirds of the way to meeting its quota of 742 members. He gave a figure of 458 paid-up members for 1966-67. If you are among the 284 who have not yet paid the dues, let these words serve as a reminder to get your dues in now. 

BLOOD BANK GROWS

Through the work of Chairman Fred Trombe and his committee, and the 48 blood donors who responded to the committee's appeal, Blanchard Post's Blood Bank account at Bender Lab has been nearly doubled.

The Bender Bloodmobile came to the Post on November 9. It was under the direction of Dr. Iwan O. Meyer and Nurse Mrs. Katherine Bradley and their staff of technicians.

Pass Out

An unexpected development occurred after the Bloodmobile departed from the Post. One of our donors became faint. To get medical assistance, George Reeber made a phone call to Dr. John P. Grogan who within five minutes was at the Post and treated the stricken individual. The doctor refused to submit a bill for the service because of the nature of the incident. For his faithful response and the manner in which he performed, Dr. Grogan was praised by Commander Cannizzaro in his report of the incident at the November 21 Post meeting.

To their credit, special recognition is due two dedicated women who donated to our Blood Bank. They are Mrs. Doris Gdula of Albany and Mrs. Ann R. Donahue of Delmar. Post. It was formed originally to relieve the commander of these burdens so that more of his attention would be given to the advancement of the principles of the American Legion. The purpose has been served and the 11-member Board since its inception has performed meritably.

However, there has been expression that the Board as it is constituted with 3-year staggering terms would have much to gain by limiting the Board member to non-succeeding terms. That is, a Board member should not immediately succeed himself.

To effect this change it is necessary to add this sentence to paragraph 1 of Article I after the last word "year": No director shall immediately succeed himself. This should not preclude a retiring director from being elected at a future election after his term expires.

Single Monthly Meeting

To encourage stronger meeting attendance, the committee has revived the issue of eliminating a monthly meeting. Sentiment in the By-Law group is to do away with the mid-monthly session.

This can be accomplished by deleting the words "and third" from paragraph 2 of Article XI of the By-Laws.

Nominations

Under the present system of nominations the membership has little or no knowledge of the candidates named for election to the Post offices. There are those who espouse the thought of attending meetings to learn what's going on at the Post. However, the present By-Laws allow only a meeting between nominations and elections. This, it has been recognized by Mr. O'Hara's committee and others, is hardly adequate. Subject to the membership's decision on the elimination of the mid-monthly meeting, the By-Laws Revision Committee offers this change for paragraph 2 of Article XII of the By-Laws. On the second line after "manner": change "At the regular monthly meeting preceding the annual election the nominating committee appointed by the commander shall present" to read At the annual January meeting a nominating committee will be appointed by the commander with instructions to present at the annual April meeting.

"Whether or not these suggested changes are effected" says the Commander, "I wish to thank Charlie O'Hara and his committee associates who have worked with him on this effort. The time and attention they gave it deserves the thanks of all of us. It shows they have the interest of the American Legion at heart. We're glad they're Legionnaires in Blanchard Post."

Participating with O'Hara on this committee were George Butman, Dick Lenseth, Win Robinson, Joe Von Ronne and Al Woehrle.

ONE FOR THE ROAD!

At a time when we should be thinking of Peace on Earth and Good Will Toward Men, the accident rate in the United States almost doubles.

During 11 months of the year, drinking is a factor in about 30% of all motor vehicle accidents. In December, the figure jumps to 55%. Add to this the fact that more than half of the year's home fire deaths occur during four monthsfrom December through March - and you begin to see that man seems to be more inhuman to himself and to others at this time of the year than at any other.

Perhaps one of the greatest menaces during this time of the year is the so-called "social drinker", who takes just a few drinks at the annual Christmas party. These drinkers are a greater menace than is commonly believed. They greatly outnumber the obviously drunk drivers, and their critical judgment is impaired to a much greater degree than realized. Pointing this up are medical facts, that in spite of what the average person thinks, drinking coffee will not make a drunk person sober. Only time will do that.

Alcohol depresses the nervous system to a great degree. Even one drink slows a person's reaction sufficiently to cause an accident. Time and time again, it has been demonstrated that if the reaction is slowed just one-fifth of a second, if you are driving 35 miles-per-hour, you will travel an extra ten feet before you can step on the brakes to avoid hitting a person, or another car.

Due to a recent sad incident, a special committee has been formed by Albany County Commander Raymond J. Steede who named Commander Joe Cannizzaro as its chairman.

The action stems from the Viet Nam death of P.F.C. James McNally, Albany, whose sister had moved to Delmar. which was used as the dead soldier's address. When the deceased man was returned to Albany the Survivor's Assistance Officer, assigned by the U.S. Army to Albany, called upon our commander for pall-bearers from the American Legion. The call came at the time of the last County Legion meeting for the funeral to be held two days later. Since the County was unprepared for such an occasion, Joe was appointed as chairman to prepare a report with recommendations to meet future incidents of this nature.

Funeral

While eight pall-bearers were requested for the McNally funeral, only four reported. These included Commander Cannizzaro and Al Woehrle of Blanchard Post. Services were at St. Patrick's Church in Albany with burial in Rensselaer. From West Point the U.S. Army furnished a firing squad, a bugler and an escort for the deceased soldier. At the graveside, Commander Cannizzaro and Al Woehrle were assigned the duty of removing the American Flag from the casket and folding it according to ritual. The Flag was then handed to the escort-sergeant, who on behalf of the U.S. Government, presented it to the sister of the deceased.

THE CHRISTMAS TREE

The Christmas tree as we know it had its beginning in Germany where it has been traced back as far as the year 1605. Covered with tinsel, lighted with candles, adorned with gilded nuts, fruits, dolls and little animals, this stately symbol of Christmas spirit graced the homes of the rich and poor alike.

It was not until Queen Victoria's reign that the tree was used in Christmas celebrations in England. Just one hundred and forty-six years ago, the tree was set up in Windsor Castle for the enjoyment of the royal children. Because it had always been part of his own boyhood on Christmas eves in Germany, Prince Albert, wanted the family to know the thrill and wonder of a tree lighted with candles and surrounded with presents for the whole family.

The lighted tree was such a delightful custom that it was taken up by the entire country and quickly found its way to America. Fifty years later President Harrison spoke of it as already an old-fashioned custom: "We shall have an old-fashioned Christmas tree for the grandchildren upstairs; and I shall be their Santa Claus myself. If my influence goes for aught let me hope that my example may be followed in every family in the land."
