TECH ERROR DELAYS BY-LAWS CHANGE VOTE

The scheduled action for making changes in the Post's Constitution and By-laws set for last month has been postponed until this month. The new date for a poll came about when a slip-up was discovered. The miss came to light by our alert Adjutant, Warren Moessner. He found the action, to read the proposed changes at the previous meeting as called for by our constitution, had not been fulfilled. This was concurred in by Post Judge Advocate George Wenger. Post Commander Joe Cannizzaro followed through by ordering the proposals to be re-published in this issue of the TEN FORTY TIMES, then to be read at the February 6 meeting. This will give the required minimum ten days notice for voting on the issue at the mid-monthly meeting on February 20.

High Interest

Attendance at the meeting was considerably greater than usual. Past Commander Charles O'Hara, chairman of

the committee proposing the changes presented the items to the floor. There was no discussion on the mandated change for the admission of Viet Nam War-time veterans into the Post.

The issue which caused the greatest amount of discussion began with the proposed change for nominating Post officials. This was tied in with the elimination of one of the two monthly meetings now held in the Legion year which in our Post customarily runs from September 1 to June 30.

Twice Monthly Meets Hold

Pros and cons on the merits of continuing to hold Post meetings on the first and third Mondays of the month began with a presentation against two meetings by Charlie O'Hara. Objections to the twice monthly meetings were spurred by the usual low meeting attendance and the burden of time placed on the officers who are committed to these

NOTICE OF REFERENDUM ON PROPOSED CHANGES TO CONSTITUTION AND BY-LAWS OF NATHANIEL ADAMS BLANCHARD POST NO. 1040, THE AMERICAN LEGION

TO: All Post Members

In accordance with the provisions of paragraph 2, Article VII of the Post Constitution and Article XVI of the By-Laws you are advised of the following proposed changes in the Post Constitution and By-Laws which be voted upon by the membership at the mid-monthly Post meeting on Monday, February 20, 1967:

1. To meet the requirements of a mandate from the United States Congress and Department of New York Headquarters of the American Legion to accept for membership in the American Legion honorably discharged members of the Armed Forces who have served during the current Viet Nam War period the following change must be effected:

Article III, paragraph 1. in the Constitution, after the words July 27, 1953, both dates inclusive add and August 5, 1964 to a date to be determined;

Article V, paragraph 4 of the By-Laws after Korean War add the words Viet Nam War period.

2. To resolve an issue relating to the term of office for members of the Board of Directors, change:

Article I, paragraph 1, add the sentence: Provided that membership on the Board shall be limited to one full three-year term. This restriction shall not include the completion of a partial term resulting from election by the Board to fill a vacancy. Furthermore, any member of the Board who has completed a three-year term may stand for election again after an interim of a year.

3. To establish a schedule whereby the slate of nominees for office in the Post will become publicly known prior to an election date, change:

Article XII, paragraph 2, after the word manner: delete the sentence commencing At the regular and ending County Committee and insert (a) The Post Commander shall appoint a nominating committee of five (5) members by no later than February 1 which will present to the membership a slate of nominees at the first meeting in April; (b) the nominating slate shall include one or more names for each office and for members of the Board of Directors and Delegates and Alternates to the County Committee; (c)

Conclusion

The Communist Party, U. S. A., undoubtedly is in a much stronger position as a result of the 18th national convention. Completely loyal to a foreign power, the Soviet Union, it remains a serious threat to our national security.

The convention actually was a "coming

out party," signifying a new era in the party's life. Gone now will be the defensive posture of an apprehensive party, fearing to identify its leadership and openly work in our national life. The party will now be more aggressive, seeking allies among non-Communists. It hopes to disarm Americans ideologically, to make them feel that communism does not represent a danger to our democratic institutions.

Yet all the time the party will be ideologically hardening itself as a weap-on of revolution—training its membership for carrying out what it believes is the "law of history" — namely, a Communist revolution in America.

BLANCHARD LEADS ALBANY COUNTY

Our Post held the distinction of having the highest paid-up membership enrollment at the December 27 meeting of the Albany County American Legion. The number was 563. Close behind was Scully Post with 552 and in third place, Fort Orange with 540. The County total membership was five percent ahead of last year. "This", says our membership chairman, Vice Commander Tom Patterson, "suggests a good time to go out after those eligible members for our Post."

"The gap to meet our quota is closing", Tom tells us. The quota is 742. At press time we were 123 short of that figure.

The chairman urges sponsors of new members for this Legion year to come to the next meeting to secure their citations for bringing new members into the American Legion during the current "Empire State" campaign—or bringing back into the Legion those former members who let their membership lapse.

The final mailing of dues notices has been released. The membership chairman hopes the response will be overwhelming. Commander Cannizzaro joins with Chairman Patterson in reminding our unpaid members of the many benefits, of which most Legionnaires are unaware, that membership in the American Legion brings.

"Remember", says Commander Joe, "We were edged out of second place membership in Albany County last year by only one. With a little more effort this year in our cooperation with Tom Patterson we may win that second spot membership in Albany County."
