IT'S YOUR DECISION

At the first Post meeting this month, on May 6, the Post members will have the opportunity to vote whether or not the Post should go ahead with an extensive expansion program.

The last meeting of the Post on April 15 was the heaviest attended business session the Post has had this year. It showed how deeply concerned the membership is about the Post's future. About ten percent of our members were at the meeting to discuss the prospects of a new building.

The plan and design as initially unveiled by the Gus Williams committee met little objection at the mid-April meeting. The main concern expressed was financing.

A suggestion was made by Fay Walworth that the meeting hall which is also used for dance and dinner functions be put on the lower floor and the lounge and bar facilities go to the upper floor. The discussion on this point was negligible. It appears unlikely that the plan-

ners will re-arrange the rooms as they are now intended.

Only mild dissent against a new building was stated. Jim Hanson wanted to know what the proposed new building offers that the existing quarters fails to provide. Chairman Gus pointed out that everyone was aware of the overcrowding that occurs on party nights at the Post. He was supported in this by Tip Nelson, a member of his committee. A reference was made to "butt-bumping" which brought some reflections on this aspect of the social life of the Post. It was stated that the over-crowded conditions has caused those who might otherwise attend the Post party functions to stay away.

Two Post members who are architects, Max Simon, now retired, and Henry Kohler, made their views known on the architectural factors involved. The drawings which the Williams committee has for its present use in getting the pro-

Parade Chairman Bob Ballantine has a full-dress parade all in readiness to begin from our Post quarters. Step-off time is ten a.m., Thursday, May 30. Past Albany County Commander and a veteran of both World War I and World War II Bob Coburn will be at the head of the parade in his role as Grand Marshal.

ceed to the Bethlehem Servicemen's Memorial Park.

At the park Memorial services will be under the direction of Post Commander Sidney Kaplan. The services will include the presentation of a new Flag to Town Supervisor Bertram Kohinke who will attach the new colors to the flag staff. As is customary for this occasion the new Flag will be raised to full-staff and then to half-staff to the accompanying "Star Spangled Banner" played by the Fort Crailo Band.

Post Chapain Kaulfuss will recite Memorial Day prayers. Floral pieces by the Auxiliaries of Blanchard Post and VFW Memorial Post of Bethlehem will be placed at the Memorial monument in the Park. The Blanchard Post Firing Squad under the command of Past Commander Dick Lenseth will fire three volleys and Taps will be sounded. Earlier in the morning a memorial service will have its traditional presentation at the graveside of Nathaniel Adams Blanchard, for whom our Post is named, in Bethlehem Cemetery.

On this Memorial Day it would be well to keep in mind another statement attributed to General Logan: "If other eyes grow dull, and other hands slack, and other hearts grow cold in the solemn trust, ours shall keep it well as long as the light and warmth of life remain."

Ending his year as our Commander, Sid Kapan says: "More than anything else this year I'm appealing to all our Post members to join with us in dedicating this Memorial Day to a day of expressing our patriotism. It would make me both humble and proud to lead the strongest contingent ever Blanchard Post has entered in the annual Memorial Day Parade. It would be a grand finale for what, to me, has been a most satisfying and fulfilling experience to have served as your Post Commander."

Parade Chairman Bob reminds everyone who has a Legion cap to wear it on Memorial Day. In cooperation with Flag Chairman George Reeber they are working on a project, with the Post approval, of distributing small American Flags to the Parade viewers. "By giving out the Flags," says Bob, "we are helping to instill a patriotic fervor among the people, especially the youngsters. It will, I am sure, have a colorful and emotional effect added to the spirit of the Day."

cluding Memorial Day and Veterans' Day, if falling on any day other than Monday or Friday, shall be observed on the following Monday. The American Legion and the American Auxiliary oppose this bill. The reason for opposition is stated briefly but with impact: "We oppose any change in the present statu-tory provisions for the observance of Memorial Day or Veterans' Day, on the basis that any change would detract from and diminish the extent of public participation in the ceremonies for which these days were set aside and traditionally associated with them." The Department Legislative Chairman of the American Legion, Mr. George L. Bliss and our Unit Legislation Chairman, Anne de Heus request that we write our State Senators to oppose this bill and weaken the chance of its passage.

BLOODMOBILE COMING

As a service to the community Blanchard Post will be host to the Abany Area Chapter Red Cross Bloodmobile on Monday, May 27 between the hours of 1:00 p.m. to 7:00 p.m.

Since the dissolution of the previously operated blood bank system this is the first time the Bloodmobile will be coming to our Post.

Arrangements for the Bloodmobile were made at a special meeting at the Post on April 8. It was attended by Commander Kaplan, Blood Program Chairman Fred Trombe and County Vice Commander Al Woehrle. The meeting was sponsored by the Red Cross and attended by representatives of the Bethlehem Chamber of Commerce, Bethlehem Lions and other Town organizations who were called upon to participate in this one-day Blood Donor program.

Commander Kaplan has appointed Hugh Stowers chairman of the committee to arrange for preparing a buffet supper for the Red Cross Bloodmobile staff. A supply of orange juice will be made available for the blood donors.

At this writing Blanchard Legionnaires who have signed up to donate their blood are Past Commander Dick Lenseth, Billy Mitchell and Art Prue. Chairman Trombe will soon be starting a telephone campaign to muster up additional donors. Last year we had more than fifty.

Anyone in good health between the ages of 18 and 60 may give blood. A newly enacted State law has eliminated the requirement that persons under 21 have the written consent of a parent or guardian.

Blood Program Is Financed

There is no direct charge for blood or blood products provided through the Northeastern New York Red Cross Blood Program. Expenses of collection, processing and distribution are shared by Red Cross and the hospitals. Approximately two-thirds of this cost is borne by the hospitals and one-third by the Red Cross.

The funds for financing the Red Cross share are secured from federated or Red Cross campaigns. The funds for paying the hospital's share are generally provided by Blue Cross and other Hospital Insurance Plans. The hospital's share is typically identified on the patient's bill as a blood processing charge.

Great care is taken to allocate the various expenses in connection with the Blood Program in an equitable manner. Financial arrangements are carefully scrutinized by hospital administrators and Red Cross officers in order to minimize costs while insuring clinically correct procedures.

Blood Eligibility Policy

The Northeastern New York Red Cross Program will operate as a total coverage program supplying the total blood needs of all hospitals in the area it serves.

Individual eligibility for blood may be obtained by one of the following methods.

1. By donating blood once a year.

2. By being a member of a donor group providing a blood collection of 20% of its membership per year.

3. By being a resident of a participating chapter meeting 90% or better of its assigned annual quota. Quotas will be evaluated quarterly.

Blood Eligibility will include coverage for the total blood needs of the immediate family. Immediate family is defined as husband and wife, children under 18, children over 18 who are unable to be blood donors, parents and parents-in-law and grandparents-in-law.

Blood coverage for those eligible shall mean either making available from supplies on hand or replacement within a reasonable period of time from future donations to Red Cross the total amount of blood actually used for an eligible patient in hospitals within the 50 United States, Puerto Rico, the Virgin Islands, and in Canada.

Blood replacement for non eligible recipients may be made by directed donation regardless of where the non eligible recipient may be hospitalized.

Replacement will be limited only by the willingness of the hospital involved to accept a transfer of credits from the American Red Cross.

Basic Donor Criteria

Don't come hungry. You should eat at your normal time. For six hours before donating blood avoid fat and fatty foods, fries, gravy soups, salad dressing, pastry and nuts. It's okay to eat fruit, cereal,

gram to the discussion and vote stage are only preliminary renderings and do not have the official stamp of an architect. This it was explained by Chairman Gus is due to keeping costs of his committee to a minimum. When the time comes to have formal drawings for the Town Building officials an architect, still to be named, will perform the necessary work to officiate and stamp the plans for the building. It was pointed out there are several steps to be taken before this is accomplished. The most important comes with the membership voting at this up-coming Post meeting.

Should the vote be against proceeding with the building program it will be a saving to not have hired an architect for these preliminary drawings, Williams noted. On the other hand when the membership approves the Williams Committee action and plans there is still to be awaited the decision of the Town of Bethlehem Board of Appeals, the State Liquor Authority and most important of all the decision of the bank which will be engaged for the financing of the project.

Gus reported it is now estimated that "ten percent either way" from \$122,000 is what his Committee now estimates the cost for the new building. This figure includes the engaging of a contractor who will do the foundation work and erect a shell for the new building. He envisages after that portion of the work is done, mechanical contractors will be engaged for the utility installations such as water and electric services. In the committee's thinking is the use of volunteer help.

For the funding it is anticipated to seek a 20-year term bank financing. The amount would be determined by the available cash assets. In the discussion it was suggested that our present Post home be sold. By others at the meeting this action was thought unfeasible. An increase in dues was also hinted at. Other fund-raising ideas were expressed to meet the anticipated seventy to seventy-five hundred dollars annually for principal and interest now thought to be required. This figure may be changed considerably, certainly up, after the selected bank determines the amortization schedule.

While the expressions of those at the meeting expounded the need for the new building — in fact, no one opposes the idea — there was a good share, usually described as conservatives, who expressed a reluctance to hasten into this costly project. It was pointed out by Bob Rosenfield and others that when the new parking lot was being considered there were many more meetings for discussing that project which was much less costly than the one now being discussed.

In the event you need back-up for your arguments with dissenters about America's position in the Vietnam crises keep handy this statement by Secretary of Defense Clark M. Clifford:

A Different Kind of War

The Vietnam war is a different kind of war and that is one reason why it is difficult, perhaps, for the American people to understand it. We are fighting a limited war. We are not fighting to destroy our enemy. We are fighting to persuade our enemy to withdraw from South Vietnam and to leave it alone. But as far as a military victory is concerned, I believe in a great respect we have already attained a type of victory in South Vietnam.

I believe our presence there, our successful presence there, has many times justified the cost to us in our men and in our treasure. And as one travels in Southeast Asia he finds that this is the general attitude. The leaders have no hope in the French. The British are withdrawing from Malaysia and Singapore. If it were not for the United States there would be no hope there. If we weren't there it would be only a matter of months before Southeast Asia, nation by nation, succumbed. That is not happening now, and it is not happening, in my opinion, because we are there, and because we have extended this shield. I believe we must continue to do it.

poached or boiled eggs, toast, bread, rolls, jam, jelly sweets, lean meat, vegetables and coffee, tea or milk.

They say please wait:

- 1. Eight weeks between donations.
- 2. Until acute attacks of allergy are over.
 - 3. Six months after major surgery.
- 4. Six months after having a baby. (Pregnant women may not give.)

5. Following immunizations:

a. 24 hours for: Tetanus, cholera, diptheria, influenza, typhoid fever, typhus, Rocky Mountain spotted fever, polio.

b. Two weeks for: BCG, Poison ivy, tuberculosis, yellow fever.

c. Small Pox: Two weeks after scab comes off, or simply two weeks if it does not seem to take.

d. One year for rabies.

Reasons For Rejections

Reasons for rejection as a donor include hepatitis, malaria, anemia (low hemoglobin), tuberculosis if active within five years, diabetes if taking insulin or oral medicine, undulant fever (brucellosis) if active within two years, heart trouble, polycythemia (too many red blood cells).
