#### MEMORIAL DAY - 1978

Parade Chairman Oliver Palmer reports that all plans have now been finalized, after some uncertainty, for the 1978 edition of the Bethlehem Memorial Day Parade. Tuesday, May 30th is the day, stepping off time is 11:00 a.m. sharp. As always, the parade will start from in front of the Post on the corner of Poplar Drive and Elsmere Avenue, and follow the route of Elsmere Avenue to Kenwood Avenue, to Adams Place, to Adams St., onto Delaware Avenue to the Memorial

This year's Grand Marshal will be Norman Bender, a World War I member of the Post and a Past Commander, with Town Supervisor Tom Corrigan serving as Honorary Grand Marshal.

The order of the line of march will be the Grand Marshal, the Police Department Color Guard, the Honorary Grand Marshal, Town of Bethlehem officials, Fort Crailo Band, American Legion, American Legion Auxiliary, Veterans of Foreign Wars, Veterans of Foreign Wars Auxiliary, Bethlehem Lodge of Elks, Bethlehem High School Band, Bethlehem Shriners, Boy Scouts, Girl Scouts, 4-H Club, Village Volunteers Fife and Drum Corps, Fire Company members and equipment from Delmar, Glenmont, Slingerlands, North and South Bethlehem and Elsmere.

The presentation of an American Flag to the Town of Bethlehem will follow at the Memorial Park. After the Park ceremony all paraders are invited to the Post rooms for refreshments, courtesy of the Post and under the supervision of Rollie Whitney.

## POPPY DAY: MAY 17 "Wear a Poppy"

The poem, In Flanders Fields, written by Col. John McCrea, a Canadian surgeon during the Second Battle of Ypres, has had the greatest impact of any poetry written during wartime. As a result of this poem, written in 1915, some 57 countries, including our own, adopted the poppy as the symbol of relief for the wounded and disabled and their survivors, a practice that continues to this day. So what better reason can there be for each American to support this program and wear a poppy.

Here's the poem as it was first printed in *Punch* on December 8, 1915.

In Flanders fields, the poppies blow Between the crosses, row on row, That mark our place; and in the sky The larks, still bravely singing, fly Scarce heard amid the guns below.

We are the Dead. Short days ago We lived, felt dawn, saw sunset glow, Loved and were loved, and now we lie In Flanders fields.

Take up our quarrel with the foe: To you from failing hands we throw The torch; be yours to hold it high. If ye break faith with us who die We shall not sleep, though poppies grow In Flanders fields.

#### NEWS FROM NATIONAL HEADQUARTERS

(American Legion News Service and National Legislative Bulletin)

WASHINGTON -- The Department of Defense has announced that former members of the armed forces separated with general discharges for unsuitability due to personality disorders may apply to the Discharge Review Boards for upgrading to honorable discharges. This new policy is available to all qualified service members separated since 1958 whether or not they served during the Vietnam era.

According to Robert E. Lyngh, director of The American Legion's National Veterans Affairs and Rehabilitation Commission, "This change was made to ensure that persons are not stigmatized simply because of a medical evaluation."

It is believed that a large number of former servicemen receiving general discharges since 1958 may qualify for discharge upgrading under this program. Notification letters to potential eligibles have already been mailed, and a second mailing is currently being undertaken. Those applying to the Discharge Review Boards should state "retroactive change under the revised DOD policy announcement" as the reason for application.

WASHINGTON -- The time limitation for conversion of "W" National Service Life Insurance contracts is rapidly expiring, according to a recent report from The American Legion's National Veterans Affairs and Rehabilitation Commission.

The issuance of National Service Life Insurance policies with numbers preceded by "W" commenced in January, 1959. The "W" prefix was assigned to policies after exchange or conversion of "RS" insurance, which is renewable term life insurance issued to persons discharged

from service between April 25, 1951, and Dec. 31, 1956. The "RS" policies are known as Veterans Special Term Insurance.

The Legion Commission noted that many veterans holding "W" type insurance are not aware that they cannot keep the limited convertible (W prefix) five-year level premium term policies indefinitely. These policies may not be renewed after age fifty. If insurance coverage is desired after the insured's fiftieth birthday, the "W" type policies must be converted to a permanent plan, or the protection will cease. The earlier the conversion is made, the lower the premium will be.
