#### RESPITE CARE

The Respite Care program at the Albany V.A. Medical Center is designed to give the primary caretaker of an eligible, disabled or chronically ill veteran, temporary relief from extended periods of home care. The care of a chronically ill or disabled person is very demanding. Respite Care allows temporary relief so that home care can continue for as long as possible.

Respite Care is of a supportive, custodial nature and does not provide acute medical care. If a respite patient's condition changes, he or she would be transferred to the appropriate acute care ward.

Respite Care is available for a total of 4 weeks per calendar year, generally taken 1 or 2 weeks at a time. It can be used for a variety of reasons—caretaker's brief hospitalization, out-of-town trip or need for a break from the responsibility of 24-hour care of the veteran.

If, at any time, you could use Respite Care Services, call the Albany V.A. hospital for a consultation. Services available include 24-hour skilled nursing care, routine medical supervision, many types of therapy, social work services as needed, and referral to Medical Center acute care if necessary. Other hospital services are a library, a barber, Bingo games, television and a canteen.

# Ceremonial Burning Of Unserviceable American Flags

Alexander Woehrle, Post co-ordinator for the committee for the disposal of American Flags that have become unserviceable, reports that 135 flags were burned in a ceremony this past Flag Day conducted at the Bethlehem Town Park by the Gansevoort Chapter of the National Society of the Daughters of the American Revolution. Following the DAR program "The Story of Old Glory", the flags were set ablaze in keeping with the U.S. Flag Code. Unserviceable flags are collected each year at Blanchard Post, at the Bethlehem Public Library and the Bethlehem Town Hall.




