Changes Suggested For Post By-Laws

The Post's Constitution and By-Laws last revised six years ago face some changes if ideas offered by a group of the Post members win acclaim.

The group is headed by Past Commander Charles J. O'Hara. Joining with him in a move for the changes are four other Past Commanders. They are Winthrop Robinson, a charter member and first commander of the Post; and three Post World War II commanders, George Butman, Joe Von Ronne and Al Woehrle.

This group also comprise a committee informally formed last year for the intent of serving as an advisory group with the intent of making recommendations for the new Post commanders that will serve the interest of the post and the betterment of American Legion principles.

Specifically, the group has three recommendations to offer. The proposed changes affect the election of officers, membership on the board of directors and limiting the action the board of directors can take on matters passed on by the general membership.

Last month O'Hara and the others in the group met to discuss these matters. Their discussions were concerned with these sections of the by-laws: Paragraph 1 of Article I which sets the standard by which the Board of Directors are chosen and their terms of office; paragraph 1 of Article III which affects expenditures of funds by the Post Affairs Committee; and paragraph 2 of Article XII which relates to election of officers and members of the Board of Directors.

"The 1960 revisions", says P. C. O'Hara, "were the first in thirty years. We deem it timely to offer these recommended changes now so that our Constitution and By-Laws can stay abreast of the times and conditions which affect our Post's progress."

"For example" says P. C. O'Hara, "our group believes it would be to the Post's advantage if this sentence would be added to the first paragraph affecting board of directors. 'No director shall succeed himself after a full three-year term. This should not preclude election of such director after one year out of office.'"

"On the expenditure of funds recommended by the Post Affairs Committee the present by-laws give the Board of

On August 11 with eight of his army buddies from the Eighth Armored Division Association Woehrle was present when their division commander, Major General John M. Devine, Retired, gave President Lyndon B. Johnson a plaque which cited him for his efforts in trying to bring about a peaceful settlement of the Viet Nam war. This year they met in New York City at which time the award for President Johnson was voted.

Directors a veto power over the Post Affairs Committee. We believe such power should rest with the membership. To that end we believe the last sentence of paragraph 1 of Article III should be amended so as to read 'It may expend from funds set aside in its name, any sums within its budget, approved by the membership' instead of the present wording which is 'approved by the Board of Directors, subject to such controls as may be set up by the Board of

Charley O'Hara, speaking for the group, goes on to state "Our present system of electing officers each year leaves much to be desired. We have a nominating committee which presents a slate of officers which only those present at the meeting hear and at the very next meeting, without the entire Post membership being aware of whom was nominated, an election is held. We'd like to see more time allowed for the presentation of a slate and for members to be made aware of the slate that is offered. To that end we recommend this change: "The candidates for election shall be nominated in the following manner: At the first regular meeting each April preceding the annual election the nominating committee appointed by the Commander each February shall present one or more names for each office and for the members of the Board of Directors and delegates and alternates to the county committee. Other names may be placed in nomination from the floor after the nominating committee's report is received." (Words in italic are proposed changes).

By bringing these recommended changes to the membership at this time it is the purpose of the group led by O'Hara to stir interest in the Post's progress.

It is expected these suggestions will be presented at the Post meetings in September and if formally presented and accepted for action follow-up measures will be taken.

Your interest in these moves can best be expressed by attending the meetings in September to see what occurs.

GRAVE MARKING FOR DECEASED VETERANS

This article is offered to explain some misunderstanding which exists with respect to the furnishing of emblem-type organizational grave markers and the flat, plaque-type, governmental marker provided through the United States Veterans Administration.

Organizational Markers

In the Bethlehem Cemetery here in Delmar there are now markers bearing the symbol of sixteen various organizations. Alphabetically, they are:

American Legion Benevolent Order of Elks Daughters of the American Revolution Delmar Fire Department Disabled American Veterans Elsmere Fire Department Grand Army of the Republic Guilderland Center Fire Department Masonic Lodge Order of Eastern Star Order of Odd Fellows Revolutionary War Veterans Spanish American War Veterans Veterans of Foreign Wars Veterans of Foreign Wars - Auxiliary World War 1 Veterans

The graves, generally, with these markers are those of members who at the time of death was a member in good standing of the organization which furnished the emblem. There are graves at which more than one organizational marker is mounted. This would indicate the deceased had been a member of more than one organization. We find an American Legion marker beside one furnished by the Elks Lodge, or a VFW marker accompanied by a Masonic emblem.

A most misunderstood problem in the grave-marking program arises when interment occurs in a distant cemetery from the community in which the deceased had been active in an organization. An alert organization upon learning of the burial of any of its members in distant places, or the burial in its community of another distant Post's member should make contact to take the necessary action for providing a grave marker.

Finding veteran's graves un-marked, especially on Memorial (Decoration) Day is a source of distress to many persons. It should be. If the proper steps are taken this distress can be lessened. The cost of providing grave markers should be borne by the organization to which the deceased had been a member.

Where markers have been removed from a grave through vandalism or other acts of desecration the issuing organization should be notified by a member of the family or other interested party so that a replacement might be made.

Governmental Markers

Federal legislation provides for the grave of every American war veteran, who dies before or after honorable separation from the services, to be distinctively marked. The markers may be in granite, marble or bronze. Bronze markers usually are sent to the family by parcel post. On the marker is inscribed the essential information which appears on the deceased veteran's discharge papers.

Funeral directors usually have the required application form for these markers. They also maintain federal forms required for the American Flag to be used at the time of burial and, where applicable, the \$250 burial allowance.

Different cemeteries have their own rules on these matters. Some will allow only the bronze marker because the marble or granite ones have a tendency to chip. Other burial places forbid the placing of any organizational type marker. The funeral director can be relied upon to advise in which cemeteries such restrictions apply.

With respect to veteran burial the important thing to remember is: the location and availability of the person's service serial number and/or discharge papers.
