Permanent Supportive Housing - Our Permanent Supportive Housing Program (PSH) is provided in two master-leased buildings collectively called "The Village Place" apartments. The buildings consist of 33 one and two-bedroom units in Saint Paul. We have 22 two-bedroom apartments for women with children, and 11 one-bedroom units for single adults. In addition, Breaking Free provides scattered-site subsidized housing opportunities through Hearth Connection and the Section 8 voucher program. Our housing advocates assist participants with navigation to access community supports including financial assistance, employment resources, educational programs, and mental health and chemical health services. For residents housed at Village Place during the past year, the average length of stay is 2 years and 8 months. Between our

4b (Code: ) (Expenses \$ 817,181. including grants of \$ 147,554.) (Revenue \$ ) Women's Program: This is the core program and gateway to other services provided by Breaking Free. After an initial intake assessment is completed, a case management plan is established and enacted. We provide advocacy services to our clients who are often dealing with concurring issues of poverty, homelessness, drug addiction, and sexual violence, all of which necessitates a holistic case management approach in order to overcome each of the barriers. Breaking Free staff provides information and referrals to appropriate services and advocates on behalf of participants with other systems and agencies. We offer weekly in-house educational support groups facilitated by breaking free staff. This group is called sisters of survival (SOS) and it's a 14-week, intensive education group that examines sex trafficking as a

Our outreach efforts cover Ramsey County as well as the City of Minneapolis. Our Ramsey County project involves several community partners including the Ramsey County Homeless Response Team. Our City of Minneapolis program is a partnership with 3 other community-based organizations as well as the Minneapolis Police Department. To develop relationships with clients on the streets, our outreach team distributes basic needs and hygiene supplies, as well as basic food resources. The goal of our outreach services is to connect vulnerable individuals who are primarily out on the streets with access to resources, stabilization services, and housing.

similar organizations to create the final job description. The search committee developed a search strategy to attract qualified candidates locally and nationally. The search committee developed a screening tool to ensure objectively and avoid bias in selecting candidates for interview. Candidates interviewed first with Breaking Free staff and then with the search committee members. All candidates were asked the same questions in both interview rounds and each staff and search committee member utilized an interview tool to rank each candidate of which an average score was used to determine which candidate moved forward in the interviewing process. After two rounds of interviews, staff and the search committee decided to have a joint third interview with the final two candidates prior to making a recommendation to the full Board of Directors. The search committee utilized the Minnesota Council of Nonprofits to determine an appropriate salary range of an executive leader position. Future compensation changes will be discussed annually amongst the full board.
