

## Step- By-Step Guide for Online MN Tax Payments

Electronic payment is now mandatory for all IRS payments as of September 30<sup>th</sup>, 2025.

To pay your personal Minnesota State tax online follow the steps below:

1. Visit [www.revenue.state.mn.us](http://www.revenue.state.mn.us) :  
Navigate to the official payment page and select “Make a Payment”

**3. Select a Payment Option:**

**6. Continue to fill out the Personal Identification steps:** Be sure to include both spouses and Date of Birth(s).

**7. Submit Payment:** Enter bank information and save the confirmation number.
