ACC will review the request on the basis of compliance with restrictions, harmony of design with surrounding structures, and compliance with minimum construction standards. Approvals are required for all types of exterior modifications or additions, including roofs, structures, fences, painting, and major landscaping, which are visible from street view.

All construction and renovations must comply with the setback provisions set forth in the Deed Restrictions and local municipalities' ordinances. Homeowners are responsible for obtaining required **permits** from local municipalities. Approval of the ACC form does not relieve the homeowner from obtaining required permits. A homeowner may be required to redo at their own expense any work performed without prior ACC approval.
