#### Problem Resolution

The Board asks residents not to contact service providers directly for problem resolution; please contact the Director over that area on the BPCIA Board of Directors and let that Director handle the problem.

### Deed Restriction Violations (DRV)

Please review your Deed Restrictions, which are on the BV Website. If you receive a DRV Letter, please take it seriously, but please do not take it personally. The best course of action is to simply fix the problem and move on. If you are uncomfortable in any manner with a letter you received or need more time to remedy things, contact a board member or Graham Management as soon as possible to discuss it.

#### Architectural Control Committee (ACC)

All improvements visible from the street must have ACC approval BEFORE work starts. Get the ACC Approval Form on the BV Website or from Graham Management.

#### BV Governing Docs & Forms

Under the "Resources" tab of the Briar Village website, there are links to important BV documents, including: deed restrictions, amendments and guidelines, and the CIA's formation documents. The Board also regularly posts the approved meeting minutes, past newsletters and important forms, under this tab.

#### Community Pool & Tennis Courts

Access Card required for admittance, and can be ordered for \$25 from Graham Management. Form is on the BV website. Pool hours open in May. Visit briarvillage.com for details.

### Garbage and Recycling: Texas Pride Waste

- Pick-up Tuesday & Friday: Trash can only be put by the curb after 6:00 p.m. on Monday & Thursday or by 7:00 a.m. on Tuesday & Friday.
- Bagged Lawn Debris is not to be left curbside except at above times. Up to 8 bags or cans
  with weight limit 40 pounds each. Landscapers should be instructed to place bagged
  debris behind fences if their work does not coincide with the trash schedule.
- No construction debris, hazardous waste, tires.
- Bundle/tie limbs 4' long.
- Heavy Trash on Tuesday & Friday (dishwashers, water heaters, etc.) No more than 2 bulky items per trash day. Note you cannot put out bulky items and let them sit on the curb for 3 days while awaiting the next heavy trash pick up day. Deed restriction enforcement will occur.
- Recycle Day is Thursday use recycle bins only on Thursdays
- If Tues, Thurs or Fri are Holidays, pick-up is skipped.
- Holidays are: New Years, Thanksgiving, Christmas.

#### How Was Halloween Invented?

Halloween is a tradition that has been continually reinvented since its ancient origins as a Celtic pagan ceremony. Yet beneath the superhero costumes and bags of candy still beats the heart of the original.

The Celts lived in what's now Ireland as far back as 500 B.C. They celebrated New Year's Day on Nov. 1, which they called Samhain. They believed that leading up to the transition to the new year, the door between the worlds of the living and the dead swung open. The souls of the recently dead, previously trapped on Earth, could now pass to the underworld. Since they thought spirits came out after dark, this supernatural activity reached its peak the night before, on Oct. 31.

The Celts invented rituals to protect themselves during this turbulent time. They put on costumes and disguises to fool the spirits. They lit bonfires and stuck candles inside carved turnips – the first jack-o'-lanterns – to scare away any spirits looking for mischief. If all else failed, they carried a pocketful of treats to pay off wayward spirits and send them back on their way to the underworld. Sound familiar?



When Catholics arrived in Ireland around A.D. 300, they opened another door between worlds, unleashing considerable conflict. They sought to convert the Celts by changing their pagan rituals into Christian holidays. They rechristened November 1 "All Saints Day," which today remains a celebration of Catholic saints.

But the locals held on to their old beliefs. They believed the dead still wandered the Earth. So the living still dressed in costumes. This activity still took place the night before. It just had a new name to fit the Catholic calendar: "All Hallows Eve," which is where we got the name Halloween.

### Diwali - October 31, 2024 - Very Important Holiday of India

This festival is as important to Hindus as the Christmas holiday is to Christians.

Diwali, or Dipawali, is India's biggest and most important holiday of the year. The festival gets its name from the row (avali) of clay lamps (deepa) that Indians light outside their homes to symbolize the inner light that protects from spiritual darkness.

Over the centuries, Diwali has become a national festival that is enjoyed by most Indians regardless of faith: Hindus, Jains, Buddhists, and Sikhs.

Hindus interpret the Diwali story based upon where they live. In northern India they celebrate the story of King Rama's return to A yodhya after he defeated Ravana by lighting rows of clay lamps. Southern India celebrates it as the day that Lord Krishna defeated the demon Narakasura. In western India the festival marks the day that Lord Vishnu, the Preserver (one of the main gods of the Hindu trinity) sent the demon King Bali to rule the nether world.

In all interpretations, one common thread rings true - the festival marks the victory of good over evil.

Non-Hindu communities have other reasons for celebrating the holiday: In Jainism, it marks the nirvana or spiritual awakening of Lord Mahavira on October 15, 527 B.C. In Sikhism it marks the day that Guru Hargobind Ji, the Sixth Sikh Guru was freed from imprisonment.

There are Five Days of Diwali.

On the first day of Diwali, people consider it auspicious to spring clean the home and shop for gold or kitchen utensils.



On the second day, people decorate their homes with clay lamps and create design patterns called rangoli on the floor using colored powders or sand.



The third day is the main day of the festival when families gather together for Lakshmi puja, a prayer to Goddess Lakshmi followed by mouth-watering feasts and firework festivities.

The fourth day is the first day of the new year when friends and relatives visit with gifts and best wishes for the season.

On the last day of Diwali, brothers visit their married sisters who welcome them with love and a lavish meal.

### 6 Ways To Keep Your Packages Safe From Porch Pirates

With the Holiday season comes online shopping and package deliveries. Unfortunately, package thieves, or "porch pirates," often take advantage of an opportunity and may frequent a neighborhood or community multiple times before moving on to another. As package theft is a crime of opportunity, they will often target houses that provide a quick in-and-out route, especially if the porch or area where packages are delivered is within 25 feet of the street and is easily visible.

But you don't have to fall victim. The Better Business Bureau offers these pro tips to prevent package thieves:

#### Don't leave unattended packages.


- If you are expecting a package, attempt to schedule its delivery when you know you will be home.
- Ask your neighbors if they mind holding on to packages delivered if you plan to be gone for an extended time.
- Some retailers (like Amazon, a BBB Accredited Business) offer "garage delivery" to avoid having packages sitting out in the open.

#### Ship to store, storefront or post office box.


- If purchasing an item from a retailer with a physical location near your home, consider shipping it there instead. Retailers will require proof of purchase or identification before releasing packages they have received.
- Some online retailers offer delivery to a pickup location within another store that has a physical location near you. Check your delivery options when ordering.
- If porch pirates are often in your area, consider renting a post office box to receive package deliveries; the cost may outweigh the headaches.

#### Use a security camera.


- Installing a home security system with cameras or a video doorbell is a great way to deter package theft, especially when highly visible. Consider including a sign that specifically states that the residence is under surveillance.
- Set up your camera alerts so that you know exactly when the package is delivered.
- Even if a package is stolen from your porch, the video evidence will help law enforcement track down the thieves (but be wary of the risk of internet-connected devices and research before you purchase).



• Many delivery companies include the option to require a signature before leaving a package, letting you take physical possession of the item as soon as it is delivered. While this



• Be sure to check with the delivery company on their policy for packages that are not signed for; they may return it to the sender after a certain number of attempts.



- Most retailers provide tracking details with links to delivery services; some even send their own emails to let you know when something has landed on your stoop. Opt-in to shipping-related emails.
- Set up your own notifications with your smartphone or app to remind you of the date and time of expected delivery.

If you fear your package being stolen, Call Mark Wilson at MJM Private Security Services, 832-797-2703. Also, file a report with your local police department and the delivery company. Depending on your delivery service, they may offer insurance or other policies to reimburse you for your losses.

#### Spotlight on Volunteers

Two of our neighbors have shown extraordinary dedication to Briar Village.

Pat McFarland and Maurice Townsend have been active members of our Citizen Patrol team for TWELVE YEARS! Both began patrolling our streets when the team was first sanctioned by HPD in February of 2012, donating their time and gasoline all these years. In all, about thirty of our neighbors have taken the training and served for various lengths of time. While that is too many names to list here, everyone's service, regardless of length, is immensely valued.

In those early years, Briar Village was experiencing numerous burglaries a year (12 in 2011 and 10 in 2012) in addition to crimes of theft, assault, etc. .... enough that I was writing a crime stats article for our (then) monthly newsletter! HPD was conducting citizen's awareness meetings monthly at the Westside Command Station on Dairy Ashford -- where wall charts were posted showing multiple categories of crime committed in all our neighboring subdivisions in District 20. BV was not alone in high stats. Monthly Positive Interaction Programs (PIPs) continue to be held at the Command Station today, but crime in our neighborhoods has waned enough that current crime stats are delivered verbally – and just District-wide totals.

The impetus for organizing our own Patrol Team in 2012 sparked after a home on Chevy Chase was broken into in the early afternoon, just after a family had departed for a doctor's appointment. Scoundrels broke into the back of the house and even entered the attic! Stepping on water pipes caused the family to return to flooding conditions, in addition to thievery. That was it...enough was enough.

Security Officer Mark Wilson says the patrol team works in conjunction with him and serves as his eyes and ears in sec-tions of the neighborhood different from his path. He stated that he receives useful information from the team – once resulting in a life-saving situation.

Though the current size of Our Citizen Patrol Team has shrunk over the years, it is still rolling along! Briar Village has 768 homes and it takes just about one hour to drive all our streets at a speed slow enough to observe driveways and en-trances on all properties. Volunteers choose their own hours to patrol, so the coverage is flexible and random. Each driver's vehicle displays signage to serve as a deterrent to the ill-intended. New team members are always welcomed. If interested, contact the team coordinator Maurice Townsend at 281-493-9392.

### A Friendly DRV Reminder

When you receive a deed restriction violation ("DRV") letter from Graham Management, do not ignore it! It's not necessary to contact Graham if you address things in a timely manner.

Be prepared to discuss who long an extension you may need to address to issue or an idea of what is an appropriate solution.

Remember that Graham is managing hundreds of DRVs at various stages of resolution. So if you see another home with concerning issues and feel they are getting preferential treatment, be certain that is not the case. Feel free to report any matters to Graham Management or a member of the board.
