- □ The applicant must have completed at least four semesters of instruction in agriscience and/or agribusiness during grades 9 through 12.

- Submit an official High School Transcript with school seal
- Submit a Letter of Recommendation from a High School Teacher or official.

- □ Submit one (1) photograph of the applicant

Other Information:

- Scholarship applications will be evaluated on a point system. There is a
 maximum of 100 points, based on GPA, FFA achievements and involvement, PYF
 involvement, community participation, and completed forms.
- If awarded a scholarship, the scholarship will be available to the student for up to five months after graduation.
- If awarded a scholarship, proof of school registration is required to obtain scholarship funds.
