HUMILITY VS PRIDE - DIVERGING LINES OF CHARACTER SEEN IN BOOK OF GENESIS

HUMILITY IS NOT THINKING LESS OF YOURSELF BUT THINKING OF YOURSELF LESS - C.S LEWIS

The names recorded in Genesis 4 highlighting the line of Cain, traces the descent of mankind from lofty names of seeming religious piety (ie Methusael meaning *Man of God*) to names that suggest satisfaction in the skills of the self (ie Jubal meaning *sound*, for he was the father of those who play musical instrumentation). Over these generations, the rise of humanistic thinking (belief in the supremacy of mankind) is subtle but nonetheless evident, as the proud nature of the fallen soul declares itself with ever increasing self assurance and in defiance of God.

In the records of Genesis 4:16-24, there is a apparent lack of humility seen in the naming of each son. There is a consistent flow of pride throughout the passing of time in the generations of Cain until history repeats itself and a descendant of Cain, namely Lamech, also becomes a murderer just as his ancestor had been. Note in Genesis 4:23-24, how on the killing of another in revenge for being wounded, Lamech waxes poetic on the self declaration that he is not to be harmed for having shed blood. Note how this is humanity's first recorded 'poem', where elegant language is used to relay the news of assault and murder. If all Art is self portraiture, as many philosophers contend, then mankind's first foray into the Arts is through the very apt depiction of itself as deeply wicked and sinful.

Furthering this self exalting act of waxing lyrical over the murder of another man, Lamech self reverently leaps on the back of God's decree over Cain that none are to kill him in vengeance for the murder of his brother Abel on pain of being avenged sevenfold. In this act, Lamech self reverently assumes onto himself the same mercy of God that had been extended to Cain without ever consulting God that this was permissible. How humanity has not changed even from it's most ancient of days, for so many today also assume the same mercy of God without ever consulting Him as to whether He will agree to such pompous and self pious declarations. Examples of this are rife in the videos of Ray Comfort's street preaching ministry when he challenges individuals if they believe they are good people and will thus go to heaven when they die. Rarely does any questioned individual ever respond with anything but self assurance that they presume themselves to be 'good' and thus suitable for a place in Heaven. The notion that God does not view a person's 'righteousness' that way seems completely unfathomable to them, just as it appears it did to Lamech.

Not only does Lamech presume heavenly protection for himself as in the manner that was mercifully extended to Cain, in his remarkable pride he escalates the arrogant, self protecting act by declaring that if Cain was to be avenged sevenfold if killed, he would be avenged seventy times sevenfold. Clearly Lamech's pride and self love was so mighty that he assumed a divine decree of protection towards another for himself, and then presumed his life was far more valuable than his ancestors in the process. Once more we see modern man reflected in ancient man, for modern society holds an extraordinary arrogance in it's assessment of previous generations for being 'uneducated', 'not knowing better' or 'primitive'. The logical implications of this viewpoint is a superiority complex displayed by current generations to view themselves as more advanced and 'enlightened' than previous generations. Thus succeeding generations drift further and further away from humble faith in God and further towards proud trust in themselves. As history proved, this came to it's tragic conclusion in the nonstop evil that was the Pre-Flood World in the days of Noah, and will reach the same peak under the abhorrent, God despising leadership of the AntiChrist in future days.

Conversely in Genesis 4:25-26, we read of the birth of Seth, the substitute for the murdered Abel, who would go on to continue the line to the incarnation of Christ Jesus himself. The name Seth means *substitute*, as Eve clearly identifies him in her naming of him, to be the physical substitute for her murdered son. Yet likely unbeknownst to her, this *substitution* was a foreshadowing of Jesus Christ, the Son of God who would be the *substitute* for sinful mankind in receiving the just punishment of God the Father for our very real sins on the cross at Calvary four thousand years later.

Seth then fathers Enos, an interesting name in that it means *mortal man*. Whilst the line of Cain is busily celebrating it's skills, accomplishments and self piety with the names selected for the passing generations; Seth's naming of his son

reveals a real awareness of the weakness of man and his insufficiency in achieving anything denoting real peace and security. This naming reflects a true humility of character that perfectly encapsulates what C.S Lewis noted on what humility actually is in that it is not thinking less of oneself, but instead thinking of oneself less. True humility is the realisation of how weak and truly limited you are and that there is someone far, far greater than you who does merit your time and daily consideration. That someone is Christ Jesus, the *substitute* for the receiving of the just punishments for our sins. He alone is a suitable substitute for each of us for He **alone** is the eternal Son of God and perfect in all His ways. Thus He is not a fallen *mortal man* (as depicted in the naming of Enos by Seth) but instead He is the eternal Son of God who is thus able to pay the debt of eternal sin committed against the eternal Father.


This humility of spirit does not end in the line of Seth with the naming of Enos. The subsequent generations also reflect a Godly reverence and awareness of the weakness of man as opposed to the majesty of the Living God. Take a look at the following names and their meanings, it bears interesting reading:

Such lives are ones free from the blinkers of selfish greed, ambition, covetousness, pride and jealousy. They are free from such heavy burdens for they look to one is cannot do such terrible and evil things. They entrusted themselves to the care of one who is perfect in all His ways and strong to save, so they have peace everlasting that in lives lived in real humility, real glory awaited them. A glory they now enjoy with hearts bursting with thankfulness and heavenly joy. Join them in the song and humble yourself before Jesus and see how good He is that He might lift you up to share in His eternal glory and know pure rest and joy forevermore. Amen.

History Revised - The Walls of Hebron

And Joshua went up from Eglon, and all Israel with him, unto Hebron; and they fought against it: (Joshua 10:36 KJV)

In Joshua chapter 10, we read of the Israelites attacking the Canaanite city of Hebron. The logical implication of this text is that the Israelites besieged the city of Hebron and did not just engage in a battle on an open field, valley or hilltop, for the text states the Israelites fought against *it*, in other words the city itself. Again the logical inference from such a recording of events is that the only way an army attacks a city and not just it's inhabitants via open battle, particularly in the ancient world of warfare, is that Hebron was a walled city.

However for many years this idea that Hebron, as recorded in the Holy Bible, was ever a walled city was mocked by secular historians, as at that point there was no evidence that Hebron was walled at the time of the Israelites entering Canaan (approximately 1500 BC). Yet this argument was a poor one to begin with as any argument that comes from silence is a weak one (hence why the argument that Christianity is a 'God of the Gaps' religion is deeply flawed as there is ample evidence to indicate that the universe has a beginning and that it had to come from something for something cannot come from nothing, thus the Christian God ably fills the supposed gaps!).



Early excavations from the 1960's at the site of Hebron (Tel Rumeide) were recommenced from earlier digs by Jeffrey Chadwick, who came to the inescapable conclusion that Hebron was indeed a thriving trading post in the 12th and 11th centuries BC (period of the Judges of Israel). Not only that but the city of Hebron covered some 15 acres and was surrounded by a defensive wall some 6 metres or 20 feet thick. Such a wall was no weak defensive structure and would require significant forces to overwhelm.

It is believed by historians today that Hebron was settled by the Canaanites by around 1800 BC. These Canaanites built the impressive walls along with sizeable gates also approximately 6 metres or 20 feet high. This was an

expertly constructed defensive structure set some 914 metres or 3000 feet above sea level (higher than Jerusalem) with the site selected for it's defendable positioning. Indeed it was this imposing structure that caused the spies of Moses to cower as seen in Numbers 13:22-28.

Hebron was used by King David for the first seven and a half years of his reign (approximately 1000 BC) as his capital city. Again, no ancient King would have his capital city without a form of defendable wall thus giving protection from possible attack. Such a thought was inconceivable in the ancient world!

These discoveries led Jeffrey Chadwick to write in conclusion that, "It can certainly be said that nothing excavated at Hebron so far, is in any way inconsistent with the biblical tradition". So as always when the sceptics attack the historicity and trustworthiness of the records of the Holy Bible, be patient and simply await the next discovery that will highlight how the historical accounts of the Bible are perfectly accurate, just as they always have been found to be.

Mankind will always convict itself, just leave it to talk long enough and in it's self adoration the foolishness will soon be announced. Again as the old saying goes, 'It's better to be thought an idiot than to open your mouth and have it confirmed'.

Then comes the completely empty statement that 'love, is love'. What does that even mean?! It's a meaningless statement that exists in empty cyclical reasoning, a method of reasoning dismissed as totally flawed and invalid by anyone who understands basic logic. Love cannot define itself, hence the Biblical definition that 'God is love' (1 John 4:16), for it is the existence of God that gives love it's definition for it is of Him. All this meaningless statement does is just add on another 'is love' to the slogan for LGBTQ+ movement (all the signs held up saying 'love is love' doesn't cut it anymore apparently) which in some ways makes sense as this whole movement lacks any clear demarcation as to it's limits. The Apostle Paul makes it very clear that if any man or angel preaches a different Gospel to the one preached by Jesus and His Apostles, that person is to accursed (Galatians 1:8-9). Thus we are prepared for such deceptions in the goodness of God through His Word the Holy Bible, and pray that we are made witnesses to others who might be vulnerable to such devilish deception so that they might be led away from the grave and towards the cross of Christ Jesus. A Destroyer of Language

The father of modern linguistics was Ferdinand de Saussure. He had a massive influence in that field. As someone I know wrote, 'Although little-known outside academic circles, his influence in the field of linguistics can be likened to the work of his contemporaries, Emile Durkheim in sociology, Charles Darwin in biology, Karl Marx in economic and political thought and Sigmund Freud in psychology.'

Saussure was an unbeliever, he had no time for the bible. He denied the existence of the non-physical soul. Again, to quote my brother in Christ, 'Saussure must and does deny any place for pre-existing concepts or of anything having a non-material essential nature, being expressed physically through language.

Any idea of us being able to know the mind of God in His revelation the Bible is impossible. So, God cannot speak to us now via meanings locked into words from 2000 years ago. Verbal Inspiration then is rubbish. So, God's word is not a book once given, inspired and preserved. Saussure drives a wedge between thoughts or concepts and the physical expression. I can't go into this too much without it becoming complicated but to divide meanings from the words that carry them is to pull language apart.

For Saussure there is no God ordained plan or purpose. Meanings are only found in the present physical world and the relations between the things in it, not anything beyond the here and now. In the Bible the name and essence of that signified by it are linked but Saussure drives a block between thoughts or concepts, (the signified), and the physical expression (the signifier).

There can be a natural connection between signifier and signified only if the sign, as the Bible teaches, has an essential meaning not affected by the passage of time. The eternal God then and His purposes give to language a stability it would not otherwise have. To divide meanings from the words that carry them is to tear language apart and render it almost useless, and if such a thing were possible, would destroy the unchanging integrity of the Word of God. The only meaning for today's linguists is the immediate one.

Modern day bible translations then have been much influenced by Saussure. This fact on its own apart from other matters should cause us to utterly reject them. The modern linguistic theories of Saussure are for example a source of 'dynamic equivalence', this lies behind the N.I.V. Underlying modern bibles is the theorising of unsaved men. You need to be aware that what you are reading is not the inspired Word of God, it is altogether something else.

Same Problem, Same Solution

Many Christians are familiar with the spiritual struggles that John Wesley experienced before he came to Christ. John was a pious man who was raised in a Christian family, the son of Samuel Wesley, a widely regarded and respected minister of the Lord. John, plucked from the burning wreckage of the family home at a young age, sought to live his life in accordance with the commandments and precepts of the Lord as seen in the Holy Bible. He was a member of the famous Oxford University 'Holy Club', a mocking term given to John and his fellow members (such as George Whitefield and his brother Charles Wesley) as they gathered in Bible study and sought to care for the disadvantaged in the neighbouring regions.

John would preach regularly on the need for repentance of sins and the placing of faith in Jesus Christ for salvation, yet he could not find any true sense of peace. He wrestled against his inner unease at his own condition as he sought to make himself as well versed in Scripture and as morally sound as humanly possible. Yet it proved to no avail. He would lament to his friends and family that he did not know the peace of which he preached. He was doing everything he could to secure assurance and peace of soul yet it would not come to him.

It was through the attending of a Bible study held by a group of Moravian Christians (whom he'd already had interactions with on a stormy sea voyage when he marvelled at their joyful praise of God amidst a terrifying tempest) that John's eyes were opened to a wondrous truth. On hearing Martin Luther's *Preface to the Epistle to the Romans*, John later observed a wonderful stirring in his soul. John wrote on listening to the Moravian preacher read the words of Luther, "while he was describing the change which God works in the heart through faith in Christ, I felt my heart strangely warmed. I felt I did trust in Christ, Christ alone for salvation; and an assurance was given me that He had taken away my sins, even mine, and saved me from the law of sin and death." The light of God had at last illuminated the heart of John and shattered the tiresome chains of labouring to secure righteousness. John was free at last because the work had been done once and for all by Christ Jesus on the Cross.

Now if we fast forward to the 1980's and to a very different circle of life, we see the Lord working in a similar manner with another man who struggled with the same burden that John Wesley experienced centuries prior.

In another world of elite ability, this time sporting and not academic, a young German called Bernhard Langer was making a name for himself on the PGA golf tour. Bernhard was a calm, composed character, with a friendly, soft spoken manner that spoke of a sure and steady childhood. Indeed this is what he would later acknowledge in his personal testimony of coming to faith in Jesus Christ. Bernhard was raised by Christian parents who took young Bernhard to church regularly along with his regular attendances at church with his school.



Bernhard did his utmost to live a good and pious life, living in accordance with all that he had been taught as a child and young man by both his parents and church attendance. This self discipline and desire to avoid a sinful lifestyle meant he was able to hone his God given talents to a level where he became The Masters Champion (one of the sports major titles) in 1985 at the age of 28. He had the world at his feet, fame, money, success, a settled family life but Bernhard noted in his testimony that despite all of this, everything a man could want out of life, he still felt empty. All his efforts to live well and secure peace had fallen flat and left him devoid of lasting hope, just as it had done with John Wesley.


Through conversation with other golfers on the tour, he came upon a peer who attended a Bible study and Bernhard was invited to join him one evening. Bernhard agreed as he was already well versed in Scriptural knowledge given his upbringing and thus saw no reason to resist the invitation.

On attending the Bible study, John 3:3 was discussed. Listening to the leader of the Bible study explain the need to be born again of the Spirit, just as Christ had told Nicodemus in John 3:3, Bernhard was stirred inside. On reflection on that night, Bernhard noted how this touched him deeply and prompted him to go away and study these words further. He couldn't accept that salvation could be gained so easily as to be born again through faith in Jesus Christ. So he continued to attend the Bible study and in the grace of God, his eyes were opened to the truth that it really is that simple. The New York Met Gala is a yearly gathering of some of the biggest names in fashion and entertainment and this years party was no different. Attendees attended the soirée in all manner of bizarre outfits, many extremely tasteless and risqué, yet one guest's costume was far more bizarre than the rest. The American rapper/singer Doja Cat caused quite the stir when she arrived looking like some Jim Henson puppet creation of what a human would look like if mingled with a cat (see picture below). This disturbing outfit was lapped up by the press (pun intended) who promptly flooded the mainstream media with videos and images of this strange woman's unsettling ensemble. Now if you are like me,



you'll be looking at the picture of Doja Cat and feel an unnerving sense of unease. The uncomfortable nature that arose from seeing this woman's fashion selection prompted me to question if something more sinister was afoot. A few days later I watch a documentary on the excavations at Saqaara in Egypt. This site is a veritable treasure trove for Egyptologists as over 3000 artefacts, many in stunning condition even after 4000 years of existence (according to secular dating), have been discovered in just one year!

In this documentary, an investigation was made into one of the funeral shafts that went deep into the Egyptian rock was launched. On reaching the small opening at the end of the burial shaft, archaeologists were stunned to find dozens of mummified cats all carefully placed. Amidst this vast array of felines, was even the first documented mummified lion cub! It was quickly determined that this shaft was the burial site for cats used in the worship of the ancient Egyptian goddess Sekhmet (see picture on next page for statue of Sekhmet).

According to Egyptologists, Sekhmet was a "terrifying goddess" (source - *Rosicrucian Egyptian Museum* website) and was the goddess of war, chaos, plagues and the hot desert sun. The story goes that Sekhmet was created by the sun god Ra as a means to destroy mankind for not obeying him and going against the principles of Ma'at (goddess of truth, order and justice). Sometimes in Egyptian mythology, Sekhmet is depicted as the daughter of Geb (earth) and Nut (sky). Sekhmet was depicted as having the head of a feline (cat or lion) with the body of a woman, as shown in the picture to the left.


However it was believed that this violent beast of a goddess had a calm side and was thus heralded as the goddess of healing and was revered as the patron of physicians and healers. Egyptians believed that there wasn't a problem that Sekhmet could not solve, especially when it came to plagues and ill health. So because of this schizophrenic nature, ancient Egyptians would offer sacrifices to Sekhmet to maintain her favour. Sacrifices would include food offerings, music played to her and incense burned. It was believed that people could speak into the ear of a mummified cat with their pleas and then offer up the said cat as a means of directly talking with Sekhmet (thus explaining the mass burial of numerous mummified cats in the Saqaaran burial shaft).

Priests to this goddess would breed cats to offer the populace a consistent supply of felines so that they could present suitable sacrifices to Sekhmet on a regular basis. Clearly from the archaeological evidence, Sekhmet was no minor deity and was widely worshipped throughout Egypt.

All this being considered, it is intriguing that there has been a recent surge of interest in ancient Egyptian religious practices, especially amongst the entertainment industry, where Egyptian religious regalia is being used with increasing

frequency in music videos and live concerts. Whilst these usages of ancient Egyptian magic is becoming less subtle with each new music artist (as seen in Katy Perry's *Dark Horse* music video), it appears to have reached a new height in the physical adoption of the very depiction of the goddess Sekhmet by the singer/rapper Doja Cat, as seen in the picture previously. The likeness is unmistakable and alarming.

Somewhat more sinister is the increasing adoption amongst the younger generation of 'identifying as a cat'! The reader may be familiar with this raising tide of insanity as it gains more and more traction particularly amongst secondary school aged children. It should hardly be surprising that this is the age range leaping onto this disturbing bandwagon as this is precisely the age range targeted by warped individuals such as Doja Cat and Katy Perry. These same young and impressionable children are following the bizarre and disturbing physical trends of Doja Cat by making themselves up to also look like cats. This is



especially prevalent amongst young girls unsurprisingly, who likely unaware of what lurks behind this trend, are adopting the physical appearance of a violently schizophrenic ancient Egyptian goddess!

These poor and mislead young girls are then using social media sites such as TikTok (or WitchTok as many rightly label it) to promote the adoption of such wicked practices and encourage other highly impressionable young people into joining this alarming trend that is actually grounded in an ancient cult!

Lost in Translation - Psalm 8:1

Psalm 8 opens with one of the most beautiful and heartfelt statements of worship ever penned. The psalmist writes:

O Lord, our Lord, how excellent is thy name in all the earth!

These words of reverence and loving awe are given to us in the KJV/AV Bible, the monarch of all translation standards. In this article we will use just this one verse to show without question how the KJV/AV Bible is vastly superior to other translations. To do this we will compare and contrast with a widely used version, the NIV. Doubtless many will be familiar with this version and will likely be using it at the church they attend and even in their personal studies at home. However I pray this article opens your eyes to what you are missing, what depths of communion with God you are being

kept from by using anything other than the KJV/AV. So let's begin our investigation by looking at the NIV's translation of this verse:

LORD, our Lord, how majestic is your name in all the earth!

Firstly the reader will hopefully notice the omission of 'O' from the beginning of the psalm as rendered in the NIV. Why has this been done? Is the expression 'O' as a vocal representation of a depth of emotion experienced suddenly archaic language and too difficult for the modern reader to understand?! If so then many pop songs need urgently revising! How is the reader of the NIV's rendition of Psalm 8 benefitting from omitting 'O'? The simple answer is they're not. There is no good reason for the removal of such an easily understandable sentiment of written emotion. None.

Does the omission have a detrimental effect however? Well yes, yes it does. The use of the word 'O' as already noted, gives the whole psalm it's sense of purpose, that of a song of personal praise by the psalmist under his personal Lord and God. In using just one letter (none are as efficient and yet as beautiful with language as is the Holy Spirit!), a joyful sense of awe is stunningly depicted so that the reader of the psalm is invited in to share in this sense of reverence and praise towards the Almighty God. It is a deeply personal statement but one of hopeful, joyful invitation also, a perfect image of the nature of the heart of the born again in Christ Jesus. For the believer in Christ is the Lord's and the Lord is the believer's. A truly personal and glorious interaction of love. Yet the joy of this love is so abundant that it seeks to share it's delight with others in the hope that they might experience the same utter joy of spirit.

Carrying on this observation, consider how frequently the psalmist speaks of directing his praise and his prayer unto God. Embark on some Biblical study and see if you can find any reference by the psalmist to an act of prayer or praise that is blindly thrown out to some mystic force such as 'the universe'. Each time the psalmist gives praise or offers up prayers it is done with a purposeful and knowing end point, the Lord God. So in just one letter, a crucial context to the whole psalm is expertly given and accurately rendered by the KJ/AV translators, namely a personal joy in the personal care of a personal God towards them.

Secondly look at the change from the use of the word *excellent* to *majestic*, as seen in the KJV/AV and NIV respectively. Again we must pose the question is the word 'excellent' too difficult for people today to understand (the justification for much Bible revision)? Of course not. It could be easily argued that the word the NIV translators have substituted it for a word less well understood ('majestic') than the word 'excellent'!

So again there's no benefit to this change, but is there is cost? Very much so! The word 'excellent' means to be 'full or complete of virtue' and 'truly worthy and valuable'. What a brilliant reflection of the Lord God Himself! Is there anyone else who is full or complete of virtue other than the Lord God? Who else is worthy of all praise and glory, whose name is more valuable than life itself but the Lord Jesus? There is none. The use of the 'excellent' is the perfect way to give worthy praise unto the perfect being, the thrice holy God that is the Lord Jesus. 'Majestic' on the other hand means to be 'beautiful, dignified or impressive', so clearly a very different meaning. 'Excellent' and 'majestic' therefore are not synonyms, they cannot be used interchangeably. The use of the word 'majestic' in the NIV renders God merely a visually impressive being who holds a dignified air. Well whoopie, what monarch doesn't? King Charles III carries an impressive, dignified air when draped in all his royal finery and yet I would not say he is complete of virtue by any stretch of the imagination! I dare say he would either! What the NIV translators have given you is a God who is no different from any other mortal monarch. Why would I celebrate and revel in that? I wouldn't; and I certainly wouldn't hang my eternity on it!

Lastly we come to that issue of swapping 'thy' for 'your'. The NIV is the 'friend of the modern reader' is removing such 'problematic and archaic' language. In all honesty however, how many people would actually find it difficult to understand the use of the word thy? Modernised versions of Shakespeare are viewed as dumbed down demolitions of a

literary master by the educated elites, but altering and revising the Word of God is deemed not just acceptable but necessary by the same high minded academics!

The use of the word 'thy' has been a contentious issue for centuries. Not because of it's literary accuracy but for it's stinging connotations of use to the pride. In the Middle Ages, royals decided that they should not be greeted in the same manner as the common man ('thy majesty') because this was beneath them and an assault to their dignity and pride. Thus the greeting 'your majesty' was used. This quickly leaked into wider society until it became an issue of pride for many as seen in this extract from a work by the 17th century Puritan George Fox:

"For Thou and Thee was a sore cut to proud flesh, and them that sought self-honour, who, though they would say it to God and Christ, would not endure to have it said to themselves. So that we were often beaten and abused, and sometimes in danger of our lives, for using those words to some proud men, who would say, "What! You ill-bred clown, do you Thou me?"

-George Fox, A Journal, or Historical Account...,1660

As you can see from this witness to the events of that era, this was a keenly felt issue. As previously noted, royals saw the term 'thy' as beneath them (even if they were willing to use it in reference to God and Jesus, an interesting thought in itself!) because the word 'thy' holds in it the meaning of referring to a 'specific individual with known familiarity'. No royal wanted a peasant, a commoner to feel as though they were known and familiar to them as a friend is to a friend. People intrinsically prefer to see themselves as superior to others and more deserving than others (have a look at modern people and prove me wrong) and this leaks out in their use of language. Consider how trans activists quickly resort to calling people 'transphobic' if their ideology is not accepted. To label someone so negatively and aggressively is to place them beneath you in estimation through the use of language. Once again, humanity doesn't change.

So by using the word 'thy' to acknowledge the excellence of God's name, the KJV/AV translators are giving a Scripturally consistent depiction of the very love of God. How so? Well just consider how God is so familiar with our plight as sinners that He gave His only Begotten Son for us so that we might be saved from eternal damnation and instead gifted eternal life in paradise. The use of 'thy' holds in it a incredibly succinct but eloquent Gospel message by revealing the depth of familiar, of specific love God has for His Creation.


Furthermore, the words 'you' and 'your' was already in common usage at the time of the KJV/AV Bible, it occurs 2616 times in it's pages. Yet the KJV/AV translators were such masters of their craft and crucially such devoted students and believers in the Scriptures, that they understood how important the correct wording was down to the minutest detail so that the nature of God would be most accurately, consistently and beautifully revealed to the reader. Praise God for their labours!

So with just the alteration of three words, 'O', 'excellent' and 'thy', the NIV translation has robbed it's reader of a God who desires to have a personal relationship with you, knowing you from before the womb (Jeremiah 1:5), taking your eternity to such depths of love that He gave His only Begotten Son for you so that you could come to Him as Father and delight in all His wondrous grace and love. If you do not attend a church that uses the KJV/AV Bible, I implore you to find one as swiftly as possible and get yourself a copy for your personal study. It's pages are filled with the words of life, given to you in your own language by God through the diligent work of amazing scholars who adored the name of Jesus Christ and desired that you would join them in praise of Him, as the the psalmist does. Amen.




