### A History of Great Is Thy Faithfulness

Thomas Chisholm's popular hymn was first penned in 1923 as Thomas thought deeply on wonderfully faithful God had been to him throughout his life.

Inspired by the words written in Lamentations 3:22-23 (see image below) Chisholm's joyful and awe filled hymn beautifully portraits the wonder of heart that is felt by the believer as they mediate on how the Almighty God has intervened for our eternal welfare so that we might be restored to him forever through the blood of Christ Jesus.

After Chisholm had written the lyrics to the hymn, he sent the work to William Runyan in Kansas, USA, where Runyan composed the now well known music that accompanies the fine verse.

Published in that same year of 1923 by Hope Publishing Company, it quickly became a firm favourite amongst church congregations. The popularity of the hymn continued to grow through it's use by Dr William Henry Hughton of the Moody Bible Institute in the USA and through the crusades of Billy Graham.

The powerful refrain demands that it is sung with power and passion, a worthy rendering of the heart of praise every believer in Christ should feel when they consider the eternal faithfulness of the Lord Almighty, that never falters or alters such is His eternal greatness.



# Challenging Questions of Faith: Predestined Freedom of Will

The seeming tension between the predestined nature of all creation, including mankind when placed against the freedom of will that man is given in either bowing the knee of worship to Christ Jesus or not, is one that many if not all believers have wrestled with at some point or another. Great volumes could be written on this question alone, but don't be concerned over a lengthy treatise here on the matter; I shall offer only an analogy of how the two apparent combatants are actually in complete harmony with one another.

Many years ago, when my wife and I decided to treat our daughter to a surprise visit to her favourite sweet shop located in a nearby town centre. We knew this was the morning's activity, yet our daughter did not as it was to be a surprise.

When we arrived opposite the shop our daughter's eyes lit up and she sweetly asked if we could go inside as she was still unaware that the sweet shop was our intended destination. Now this sweet shop was a mini Willy Wonka factory, a child's dream (and many adults as well) with every type of sweet, chocolate, sugary drink, fudge, toffee the mind could salivate over. Such was the mind boggling array of choice that it would be easy for the morning to be lost in a tear filled paralysis where my daughter would be locked in a hundred different decisions unable to fix on just one.

However, knowing our daughter we were confident she would decide on a selection of traditional pick and mix so that she could walk out with a bulging bags of treats as opposed to one of the hundreds of chocolate bars or fudge slabs available. After a few minutes of drool laced, bulging eyed wonder from our daughter as she scanned the contents of the shops, she did indeed choose an array of our forethought of pick and mix.

As we exited the shop, the look on our daughter's face was one of delighted surprise over the unexpected visit to her favourite sweetshop, where her parents gave in to her request to go inside, ending up with a hand struggling to contain a delicious assortment of treats. From her perspective she was exercising her free will in noticing the shop, asking to go inside the shop, asking for a small purchase and the fulfilment of that expression of free will was the hoped for and requested bag of her favourite sweets. Here we have the expression of man's free will.

Yet all the while, unbeknownst to our daughter, the visit to the sweetshop was already decided by my wife and I.
Furthermore the knowledge that even with the choice of hundreds of options, our daughter would select a certain option even before she had chosen freely herself with no interference from ourselves. We were confident of her choice as we are her parents, knowing her likes, dislikes, mannerisms, thought processes etc. Therefore, our prearranged visit and confident prediction of sweets selection was an example of God's predestination of life's unfolding steps.

God is our Heavenly Father, who moves all things according to His predetermined will. In the course of the unfolding of these determined events, we are as blissfully unaware children going along expressing our desires as though they are new information. All the while however, God knowing us intimately having made us and gifted us life, already knows our thoughts, desires and expressions before they are made and therefore does not require Him to exert obvious influence on the decision of the individual for His already determined will to come to perfect fruition. Thereby we do not enjoy a false freedom of will, a veneer of freedom as God does indeed allow us our choice, yet as the knowing parent, He has already moved to provide the choice and the fulfilment in His eternal goodness.

### **Book of Ruth - Part Five**

We resume our study of the beautiful little book of Ruth by diving headfirst without delay into Chapter 2 verse 5, which reads, "Then said Boaz unto his servant that was set over the reapers, Whose damsel is this?"

Choice of language must be defined and precise if it is to represent the movements and determinations of the Lord God. This careful selection of language to convey a deep truth is evident in this verse as the Holy Ghost inspires the writer of the Book of Ruth to use the term, "Whose damsel is this?" As opposed to 'Whose that damsel?'

The choice of term reflects the nature and order of creation, the provision of roles and responsibilities of man and woman, and ultimately who holds the ownership of the humble and repentant of spirit.

Boaz's words show the clear delineation of the scriptural role of the man towards a woman. Man created first by the ordination of God, is given the task of leadership and protection towards the softer of the sexes, the woman. This is not a demonstration of oppressive manhood seeking to 'own' the woman, in this instance Ruth. It is an awareness by Boaz that this lonely woman is not being cared for, not being provided for, nurtured or protected in what was and still remains a cruel world of sin and wickedness. Boaz reflects the Scriptural role of the man, to strive to glorify God by taking on the responsibility given to him by God in leading, protecting and nurturing the woman, ie Ruth.

This Biblical ordination of the roles of man and woman are so vital as it reflects the very nature of Christ and the church itself. This matter is spoken of by Paul in Ephesians 5. Jesus gave himself for His church and continues to provide, protect and nurture His church to this day and will continue to do so until He returns to take His bride that is the church, home to glory with Him in His Father's house forever.

Furthermore, Jesus is the one who has bought us with His own blood and thereby we are His property. In His eternal goodness and mercy He delights in us, the ones He purchased with His own blood, by protecting, providing and nurturing us from eternity past to eternity future. This wondrous truth is reflected in Godly marriage between a man and a woman and is demonstrated here in the text by the figure of Boaz, who is very much a picture of the Lord Jesus.

As we read in verses 6 and 7 via Boaz's servant, we again see the character of Ruth shine through in her daily task of humble gleaning, the picking up of the fallen barley grains that were left by the harvesters for the benefit of the poor, widowed and foreigners. Verses 6 and 7 highlight Ruth's hard working nature, a work ethic that reflects the words that her great, great grandson Solomon would advise all to engage in through Ecclesiastes 9:10 ("Whatever thy hand findeth to do, do it with all thy might"). As we have previously noted, it is all too easy to fall into depression in times of suffering, yet a heart rich in faith, whilst still feeling the hardship does not remain in bitter sadness. It's hope is grounded in the LORD, and strength is drawn from His reassurance that when God is with us, who can be against us (Romans 8:31).



Let us indulge in a quick tangent here as we consider an important side note to the events of Ruth's life. Dear Ruth did not have these wondrous words from God that bring us such welcome strengthening when we walk

through days of testing and trial. Such sources of hope as Romans 8:31 were not yet revealed to mankind in the written word. Yet such is our desire for signs or miracles in our present day, that we sometimes long for the days of the Old Testament. Days when God's power was manifest in visible signs and wonders. Yet consider how many signs and wonders came from the hand of God in correction or judgement of man's sinful nature. This is why Jesus spoke so when He said it is an evil generation that asks for signs (Matthew 16:4). The demand for signs and wonders is the expression of sinful doubt and mistrust. It is reveals a heart that has misunderstood the use of signs and wonders by God. They are used to display His power, His might and validate the truth of His eternal word which is very much complete in our Holy Bible.

Romans 8:31

What shall we then say to these things? If God be for us, who can be against us?

Yet many today ignore this sound theology as dismissing feeling and emotion within faith. Do you believe that if offered the revealed word of God or the experience of ever changing feelings during hours of hardship, Ruth would still have chosen to live in feeling over the certainty that is contained in God's word? This is why it is crucial for every believer to have a daily intake of God's word, to anchor their faith in the Word, not the sensation. In this anchoring, real, consistent hope can flow readily as it rests on the might and truth of God's unchanging word and nature, and not on the ever changing weakness and nature of man.


Returning to our study of the text, we read of the first outpouring of mercy, grace and protection from Boaz towards Ruth in verses 7 and 8. After hearing Ruth's plea that she might be allowed to continue gleaning in Boaz's fields, Boaz immediately extends mercy towards the grief stricken Ruth. The mercy is in the form of his permission for her to

continue as requested, to glean in his fields. Yet his heart full of compassion towards this humble, hard working soul is not finished pouring out kindnesses. He extends the kindnesses by ensuring that she remains in his fields where he has ensured her protection by instructing his servants that no one lays a hand on Ruth. Further he instructs her to help herself to the water reserved for his workers. This kindness should not be diminished or overlooked, for working the length of the day in the punishing heat of Israel would've taken a significant physical toll on the workers and gleaners. So this kindness is a welcome source of physical restoration to dear Ruth.

This act of kindness by Boaz is a beautiful depiction of the difference between mercy and grace. Boaz extends his mercy to the humble Ruth who has placed herself in a position of humility and hopeful trust in the goodness of Boaz. This is supplied and then exceeded in his grace. This reflects the depth of grace that God extends towards we sinners at the moment of salvation. God not only forgives us our debt of sin through the offering of the blood of His Son Jesus Christ; He then provides a mighty measure of blessing not earned or deserved by man but very much gifted to man so that we have the righteousness of Christ imputed to us. This means that we share in the glory and righteousness of Christ so that we become redeemed children of God. This is what it means to be brothers and sisters in Christ. Jesus is the firstborn, the pre-eminent only begotten Son of God, but we are brought in by the grace of God to share in His eternal glory. Boaz reflects this incredible nature of God in his actions towards Ruth, and we as believers in Christ are to do likewise. Yet how many of us live so? We shall end on this important note, that those who do not extend such compassion to others when they claim to be believers in Christ are bringing great dishonour to the name of God. Therefore pray the Lord softens your heart and makes it burst with compassion towards others, so that they may see the very nature of God in your actions and expressions of the heart. #### **Genesis Impact**





# Provision for a Nation Part 5

A couple of months ago we left the scene of Joseph in a pit somewhere in the land of Dothan. Reuben had managed to dissuade his brothers from the act of immediate murder, with the intent of rescuing Joseph at some later point, possibly in order to regain favour with his father Jacob.

Verse 25: And they sat down to eat bread: and they lifted up their eyes and looked, and, behold, a company of Ishmaelites came from Gilead with their camels bearing spicery and balm and myrrh, going to carry it down to Egypt.



Apparently the brothers hadn't lost their appetite despite their distasteful actions. Sitting to eat bread is a phrase synonymous to eating a meal, as bread was the staple of all meals partaken of. One would have imagined that Joseph was languishing in a pit some distance off as listening to his pleading for help (which one has to humanly imagine was the case) would have been somewhat off putting to even the hardest of hearts. They didn't like the sight or sound of him.

It is whilst this meal is underway that they notice a caravan of traders. They were seemingly camped within view of a main trade route to Egypt and saw the approaching company with sufficient time to have a conversation about selling Joseph rather than leaving him to die.

Gilead was a place noted for its gums and balsams as is seen in Jeremiah 8:22 – "Is there no balm in Gilead?" Myrrh was a particularly sort after product in ancient Egypt due to their advanced use of medicine and in the embalming process. Myrrh was used in embalming due to its scent but also due to its ability to slow decay through its antibacterial effect. It also had multiple uses in medicine, being used in the ancient east as a cure for indigestion, ulcers, coughs and colds, sore throats, arthritis, all the way to leprosy and syphilis. On a lighter note it would also be used to flavour foods.

Verse 26-28: And Judah said unto his brethren, What profit is it if we slay our brother and conceal his blood? Come let us sell him to the Ishmaelites, and let not our hand be upon him; for he is our brother and our flesh. And his brethren were content. Then there passed

by Midianites merchantmen; and they drew and lifted up Joseph out of the pit, and sold Joseph to the Ishmaelites for twenty pieces of silver: and they brought Joseph into Egypt.

Judah suddenly decides that there is a profit to be gained here from the black swan of the family, and the rest agree that monetary profit is decidedly more preferable. If a man can sell something of no use to him then you will generally find him glad of the option.

However monetary gain is not the only reason

for Judah deciding against murder in favour of this now available recourse. He also mentions the covering or concealing of a brothers blood. Since the days of Cain the spilt blood of an innocent life was regarded as it crying out to heaven and so the act of covering was not just to conceal the human act of murder from those that may discover the scene but also to conceal it from the Almighty as well. Oh how poorly we as humans perceived the omniscience of the Lord. But guilt was already pricking the conscience of Judah and he wanted a cleaner way out. He doesn't however come to the aid of Joseph and defend him, but rather looks to soothe his conscience at the same time as retaining his standing with his brethren.


Now we come to the issue of the use of both the terms Ishmaelites and Midianites to refer to the company of men. Some contend this is an inconsistency. But why? Both the Ishmaelites and the Midianites have the same ancestor – Abraham. In Judges 8:24, Midianites are called Ishmaelites. There is no reason to assume that these are not one and the same, just different ways of referring to the same group of people.

The twenty pieces of silver was the going rate for a male of Josephs age. In Leviticus chapter 27:5, Moses fixed this amount as the value of a boy between the ages of 5 and 20 years old. The price of a slave of full physical maturity was 30 pieces of silver or shekels (Exodus 31:32).

And so we find out the ultimate end of Josephs rather eventful journey after leaving his father in Hebron on a simple errand - Egypt, the greatest land humanly speaking of the ancient near east. It is entirely feasible that unbeknown to Jacob,

Joseph now sold into slavery may well have passed closed by to his father on his way from Dothan to Egypt as trade routes went close to Hebron. Joseph would also have been well aware of the binding nature of the transaction, which had just occurred involving his person being procured as a servant. He was not naïve enough to think this was all a misunderstanding and it would be ironed out in the near future. There must have been tremendous distress and confusion on his behalf. He was also unaware of Reubens plans to save him from his plight in the pit, and as we shall see it appears Reuben was unaware of the events that unfolded on the arrival of the Midianite caravan.

Verse 29-30: And Reuben returned unto the pit; and, behold, Joseph was not in the pit; and he rent his clothes. And he returned unto his brethren, and said, The child is not; and I, whither shall I go?



The statement that Reuben returned to the pit is sufficient evidence that he was not present at the time of Joseph's sale. This has come as quite a blood running cold moment for Reuben, who was, as we surmised earlier in our study, hoping that his act as Joseph's saviour would return his standing in the family. He expresses his gut wrenching grief

and distress in the traditional manner of rending his garment – done by grasping the inner garment of dress at the level of the neck with both hands and tearing downwards a few inches. Filled with alarm and panic, probably also partly due to the fact that if Joseph had some how escaped of his own achievement and was now headed back to Hebron to Jacob, then they were all in deep trouble, he runs into the gathering of the rest of his brethren and cries out that Joseph has gone.

Their lack of surprise would have been immediately informative! And his further cry of "whither shall I go?" shows his own great distress, to the point of he has no idea what to do with himself. Does he mount a rescue? Does he go home? How can he face Jacob? His plans for personal glory have vaporised and now all he sees is yet further shame heaped on his head even more than the others as the eldest.

And so another plan has to be concocted. This is the nature of sin, it piles itself up one on top of another until you are thoroughly buried.

Verses 31-34: And they took Josephs coat, and killed a kid of the goats, and dipped the coat in the blood; And they sent the coat of many colours, and they brought it to their father; and said, This have we found: know now whether it be thy son's coat or no. And he knew it, and said, It is my son's coat; an evil beast hath devoured him; Joseph is without doubt rent in pieces. And Jacob rent his clothes, and put sackcloth upon his loins, and mourned for his son many days.

Forensic science was not a feature of this time and blood was blood. The brothers in their plan to cover they're guilt did what we all do as sinners and pass the buck. As a crude analogy it was the "it was like this when I got here" ploy. They are denying all knowledge that Joseph ever reached them and that they have found a coat that looks similar to Josephs – but they cant be sure, 'so what do you think dad since you gave it to him?' The brothers are cruel, they know Jacob's love for Joseph and they know the effect this will have upon him. They may have even felt a sense of revenge upon their father for the favouritism that he had bestowed on Joseph. The text says that they sent the coat; someone acted as messenger, as they are all too gutless to stand before Jacob, and even the message was cruel and blunt - "found this, doesn't look good – is it Joseph's or not?"



Jacob immediately recognises it and comes to the desired conclusion; his beloved son has been attacked and mauled to death by some wild beast. In the land at this time shepherds would have been on guard for lions and bears and wolves. They were accustomed to dangerous animals and indeed fighting them. In retrospect this is easy to say but, if Jacob had controlled his grief and taken a look at the coat as it was presented to him, it appears that the brothers did not tear or rip it. This might have struck him as a little odd and maybe even brought suspicion given that he

had assumed that Joseph had been rent in pieces. Seeming the wild beast had undressed Joseph of his coat first!

But we are all blinded by grief. We rarely act rationally when faced with the loss of a loved one. Jacob is no exception.

So we will leave the story here for now – Sin layered upon sin to achieve an end. Jealousy enacting revenge. A parent's heart-breaking grief the consequence of the worldly desires of the offspring. How often in our youth have our sins brought grief of untold pain to our parents. How much do we find ourselves unaware of this until we too as parents find ourselves feeling it also.

As my father said to me once – the way of sin is hard. May we all keep this in mind and be eternally grateful that we have been washed white before the Lord. Amen.

# Ancient Briton and the Word of God – Part Two

# Hallmarks of Design – Kangaroos

Kangaroos are a marvel of design being the only land animal that hops for the majority of it's travelling movements. Living in the dry open landscape of Australia and some of the surrounding islands, Kangaroos require a great ability to travel long distances to obtain food and water. The legs of the kangaroo operate as springs, with the tendons within the hind legs stretching like elastic bands on landing from a hop. Then at the point of initiating the next hop, the stored potential energy within the tendons is released in a great burst of kinetic energy, powering the next sizeable hop. Such a method of movement is highly efficient making it excellent for traversing the great barren stretches of the Australian outback. Furthermore the hopping mechanism also aids the breathing efficiency of the Kangaroos lungs, making the whole system combine beautifully to form one very effective design. Such design has been replicated by brilliant robot engineers, although their best efforts pale in comparison to the amazing efficiency of the Creators design contained within the Kangaroo.

The strength of the tail is so notable that it can be

used by the kangaroo to support it's full body weight for short bursts allowing it to kick it's opponent (see photo on previous page).

Being a marsupial mammal, the kangaroos young live in a pouch after their birth. When the young kangaroo or 'joey' is born, it climbs into the mothers pouch locating the teat for nourishment and remains in the said pouch for the first nine months of it's life. The joey will then start to leave the pouch on occasions as it is weaned. Whilst the joey is out of the pouch and being weaned, the mother can have another joey attached to the teat, whilst carrying an unborn embryo. This is parenting multitasking at its finest and shows how truly incredible God's design is in it's care and productivity.

Furthermore the mother is able to delay the development of the embryo in case the existing joey has not been fully weaned yet or if there are drought conditions being experienced meaning a lack of suitable nourishment for herself and the offspring. When the time is suitable, her body sends hormones to restart the embryo development in her womb. Such is the grace of God that He has allowed for such a staggering piece of design so that the kangaroo kind can live and reproduce effectively even in a sin cursed world that shows itself harshly in the barren landscape of the Australian Bush.

Kangaroos have an amazing ability to withstand temperatures of up to 50 degrees celsius! They remain cool by licking their legs where the water evaporates cooling the stored heat within the body. This is boosted

by the large network of blood vessels contained within the legs of the kangaroo making a highly effective cooling mechanism. This is further heightened by the fact that when temperatures do rise, the blood of the kangaroo flows in greater quantity to the legs, the cooling centre for the kangaroo. They also remove heat by sweating and panting similar to dogs.

How the Lord stored such abilities within the kangaroo knowing that these features would be needed for the post-flood world shows His amazing care and provision for all creation long in advance of it's actual need. 
Staggering detail gained from a tooth!


