#### Introduction

Thank you for your interest in applying for the Impact 100 Richmond \$100,000 grant. We are looking forward to going through the grant application process together. Our Grant Application aims to learn about your specific funding request, as well as your organization and the community need(s) it serves.

Since 2009, Impact 100 Richmond has awarded more than \$2 million to over 25 local nonprofits, targeting high-impact projects that **transform** our local community.

**Transformational grants** allow organizations to change themselves, or the community, by creating a new paradigm, expanding operations, developing a new project, or initiating a new service area, idea, or program. Transformational projects can also respond to the current environment, change the way a community thinks, or dare to shift consciousness.

We fund specific nonprofit projects that:

- Foster change and have a long-term positive impact;
- Are new programs or expansions & improvements of existing programs that can change the way an organization or a community operates;
- May be programmatic and/or capital (i.e. buildings) in nature;
- Can demonstrate specific, measurable goals.

All grant applications must meet the following criteria: (i) the organization has a 501c3 status, an annual operational budget above \$250,000, has been in existence for 36 months or longer, and currently is in good standing in the state where the entity was formed; (ii) the project must serve needs in the City of Richmond and/or the surrounding counties (Chesterfield, Goochland, Hanover, Henrico, and Powhatan); (iii) the funds sought should be utilized within 12-18 months, and (iv) the program should demonstrate sustainability following the use of Impact 100 Richmond funds. We invite non-profits to collaborate on projects but the applicant must meet the above criteria on a standalone basis.

We award funding in five focus areas: Arts & Culture, Education, Environment & Sustainability, Family, Health & Wellness. We will review your materials in a committee structure designed to create a fair and impartial review.

Our intention is simple: we recognize your resources are valuable and don't want to make this process harder than it needs to be! We are a group of committed Richmond-

area based volunteers who have spent the last year raising funds to make significant grant funding available in our community and could not do our volunteer work without your expertise.
