OLD BUSINESS

The doors for the storage trailer were too tall and wide to fit properly; lumber was purchased to build a wall. Cleaning and painting took place, and there is an intention to donate the doors to someone else.

Discussion on consideration of Resource Solutions LLC for future services.

NEW BUSINESS

Steven Spies was hired as Deputy Fire Chief after interviews with three candidates. Chair Commissioner Guthrie signed the employment contract.

Commissioner Guthrie distributed benefits books via WFCA for commissioners and staff to review. The district is evaluating the possibility of offering benefits to full-time employees and commissioners.

The September Financial Analysis was reviewed. Dwight Remick prepared the packets, and an investment transfer letter was given to the Chelan County Treasurer.

The Dryden property was leased at a rate of \$300 per day during the wildfires to serve as a designated parking area for fire trucks and equipment. An Emergency Facilities and Land Use Agreement with the USDA Forest Service commenced on 10/8/2025 and will remain in effect until the conclusion of the Labor Mountain Fire incident.

Chiefs Report:

Chief Lee announced that the District has received a \$386,000 State Grant to reimburse summer crew wages.

Chief Lee informed the Board that the State Auditor will commence an audit of Fire District 6 on October 20, 2025.

The WSRV audit is scheduled to take place in April or May of 2026.

Chief Lee provided an update regarding active wildfires in the area, noting effective collaboration among teams. The Forest Service has proposed a controlled burn of approximately 2,000 acres along Mission Creek. No night crew members are assigned to the Sugar Loaf Fire, and the Labor Mountain Fire remains at critical status.

Chief Lee stated that the Company Officers Meeting for Fire Districts 6, 9, and 3 is set for October 21, 2025, at 10:00 a.m.
