#### **OLD BUSINESS**

Commissioners discussed the Letter of Authority for Financial Fund Designation with the County Treasurer for Dwight Remick. Commissioner Schmitten made a motion to approve the Letter of Authority for Dwight Remick. Commissioner Larson seconded the motion. Motion passed.

Commissioners tabled the At-Will Volunteer Form. Will discuss at next meeting. Commissioners would like to include a disclaimer on liability for personal vehicles on form.

Chief Lee will be meeting with Insurance adjuster tomorrow on the water leak issue at the Dryden Fire Station. Plumbco came out with new equipment to trace back leak. Found that water line was right next to sewer line. Plumbco gave quote of \$17,460 to complete entire project.

Commissioners discussed Levy status. Commissioner Schmitten informed the board that Mike Steele was unable to meet. Commissioners suggested sending photos and a list of current issues in an email to his office. Commissioner Schmitten also presented a levy proposal by Michelle. Michelle would like to run the levy in the August Election. Suggested Commissioners work on getting the word out, coming up with a contact list, and getting everyone onboard.

Chief Lee presented Michelle's Scope of Work Contract. Chief Lee informed the Commissioners that the Volunteer Association has agreed to cover the cost of the contract.

Chief Lee presented Commissioners with paperwork from Cashmere Valley Bank to increase Credit Card Limits. Commissioner Guthrie signed the request.

## Chiefs Report:

The Chief informed the Board that LWFR, Fire 3 and Fire 6 were partnering up with a Continuity of Coverage Plan for all major fires within district areas to help with Insurance Ratings.

The Chief informed the Board that the Insurance and Ratings are wanting the District to Pump Test Wildland Trucks. Currently trucks are not rated. It would cost approximately \$3,000 to \$4,000 to test trucks.

The Chief informed the Board that he and Michelle would be working on a 4-year FEMA grant to hire an Assistant Chief Recruitment Officer. Commissioner Larson made a motion to approve the pursuit of grant with Michelle. Commissioner Schmitten seconded the motion. Motion Passed.

The Chief informed the Board that the District had 68 calls in December of 2024.

The Chief informed the Board that the First Due Reporting Software was going live starting February 1, 2025.

The Chief informed the Board that the new WEMSIS reporting system took about 3 hours to complete 1 report. Now it takes about 15 to 20 minutes per report.

The Chief informed the Board that Hay Canyon Neighbors were having a problem with another neighbor burning on his property. District informed him he needed a permit to burn. The neighbor burned again. District contacted DOE, they will come in and enforce the illegal burning.
