

- To develop a literature review in collaboration with our community partner, addressing youth violence prevention in the selected communities.


OBJECTIVES:

What do the history, data, and research tell us?



Statistics and History

- Homicide is the 3rd leading cause of death for youth ages 10-24
- For African American youth, homicide is the No.1 leading cause of death
- As of 2023, homicide rates and violent crime in general still remain elevated compared to pre-pandemic, 2019 levels
- Gun violence rates in particular has seen a sharp increase since the start of the pandemic
- African-American youth experience the highest rates of community violence exposure and violence-related injuries

Indicators of Violence



Poverty

- Familial/parental unemployment
- Built environment, neighborhood concentrated poverty
- Economic deprivation, lack of social and familial support as an effect

Parental Support

- Strained relationship with caregivers
- Adverse childhood experiences
- Lack of support, impacting school performance
- *Gender



Internal Stressors

- Feelings of distress and perceptions of violence
- Perception of social information as aggressive behavior
- Hypervigilance to violence
- Unable to relax due to survival mode
- Sleep issues \rightarrow school

Interventions and Recommendations

Interventions

National Interventions:

Youth violence is an issue throughout the United States among black and brown communities.

- An intervention using an anti-violence approach to addressing the root cause of violence
- A community-based intervention paired children who were treated for peer-related assault injuries with mentors

Interventions in Prince George's County:

- A hospital-based violence intervention that seeks to improve client's health while preventing repeated violent injuries
- A sports-based community intervention that uses basketball to reduce crime

Recommendations

Interventions for youth violence that include both intrapersonal and interpersonal interventions involving the community have show to be successful at reducing violent behaviors



1.Create supportive and safe environments for children that experience violence that extend beyond the home.

Creating safe second and third spaces and early childhood development programs



2. Community mentorship programs

Seeking mentors that despite experiencing adversity grow up to be successful and not involved in crime or violence



3. Use Trauma-informed approaches

Group exercise, art expression and group therapy
