o ensure the health and safety of your dog and all other guests, we require that all of our lients agree and comply with the following terms and conditions:

I specifically represent Cosmo's Playhouse that I am the legal owner of my dog. In addition, my dog is healthy, my dog meets Cosmo's Playhouse vaccination standards, my dog as not harmed or shown aggression or threatening behavior towards any person(s) or another log (s), and has not been exposed to any known infectious disease within the 30 days mmediately before admission to daycare. I further represent that each time my dog is brought to Cosmo's Playhouse, I will be recertifying that my dog is in good health and has not had any communicable illness of any kind for 30 days before admission. I further agree to inform cosmo's Playhouse of any changes in my dog's condition and/or behavior before any daycare isit.
I understand that my dog must be spayed or neutered before attending aycare (if 7 months of age or older).

I understand daycare is offered between _7 A.M. – _5:30 P.M. Dogs that are not picked up by closing time will be taken to Tina's home and the standard boarding rate will be applied.
I understand that daycare is by appointment only. If you have certain days you want your dog to come regularly on, please let Tina know and we will get them on the schedule.
All dogs must be dropped off by 11 am for daycare. No dogs will be accepted after that time, for safety reasons.
Payment is due by Sunday evening of each week. Invoices can be issued or you are welcome to pay by PayPal ,Venmo,Cash App, Zelle, cash, check or credit card at the time of pick up.
I understand that my dog is required to be fully vaccinated (including distemper, parvo, rabies, and bordetella) and I will provide Cosmo's Playhouse with proof thereof from my veterinarian. I agree to provide Cosmo's Playhouse with annual updates on my dog's vaccination records. I acknowledge that it is my responsibility to ensure that my dog continues to be fully vaccinated and that Cosmo's Playhouse reserves the right to remove my dog from the facility if they are not fully vaccinated.
I understand that my dog must have flea protection in the form of a pill or a topical liquid such as K9 Advantix, Advantage, or Frontline.
If a topical is used, I agree to not bring my dog for 48 hours after applying for the safety of the other dogs. Flea collars are not allowed in the daycare. (for safety reasons)
I understand that I am not permitted to bring personal items to daycare such

Specialtly collars/trackers will be swapped out for generic collars to prevent any breakage to the system.
I understand that the leash-free environment at Cosmo's Playhouse provides dogs the opportunity to play in close physical contact, including with their teeth and paws. I acknowledge that no amount of supervision or personalized care by Cosmo's Playhouse, its agents, or its employees, can prevent the possibility of injury or illness to my dog.

• I understand that daycare play at Cosmo's Playhouse is a cage-free service. I accept the risks involved and agree that I am solely responsible for any damages that result from injuries caused by my dog while at Cosmo's Playhouse. I agree to indemnify Cosmo's Playhouse from all claims, liabilities, costs, and expenses, including court costs and attorney fees, arising out of any harm or injury caused by my dog to other dogs or people. I authorize Cosmo's Playhouse to do whatever is deemed necessary for my dog's safety, health, and well-being, and I agree to assume full financial responsibility for any medical expenses incurred. I expressly waive and relinquish all claims against Cosmo's Playhouse, its employees, agents, and representatives for any injury, illness, or harm to my dog including death. Under no circumstances will Cosmo's Playhouse be liable for consequential damages or the death of my dog.
I understand that while playtime is cage-free, Cosmo's Playhouse is not 100%
cage-free.

In the event any provision of this agreement is declared by a court of competent jurisdiction to be unenforceable, the remaining provisions shall remain in full force and effect.
