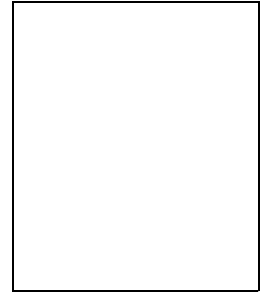

Business meeting has compulsory rules and regulations and members should obey the rules which are in favor of members
- b) **Social Media and Digital marketing:** All vendors highlighted to our social media page and group, which is highlighted as per Admin rights. Page has an only admin rights to viral post and group on social media have rights to all those vendors who has join our group.
- c) **Mobile Application**
 - Member Can Change their Images on Daily Basis by themselves.
 - Any Vendor should give clear images in jpeg format and information on our email id we are not responsible for any misinformation and unclear images given by vendor

General:
