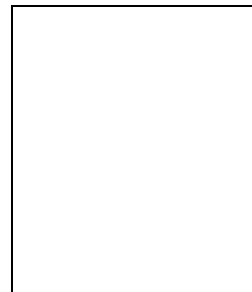

We provide any one facility to the members according to their choice. If member want more than one, he or she will to pay extra for that.

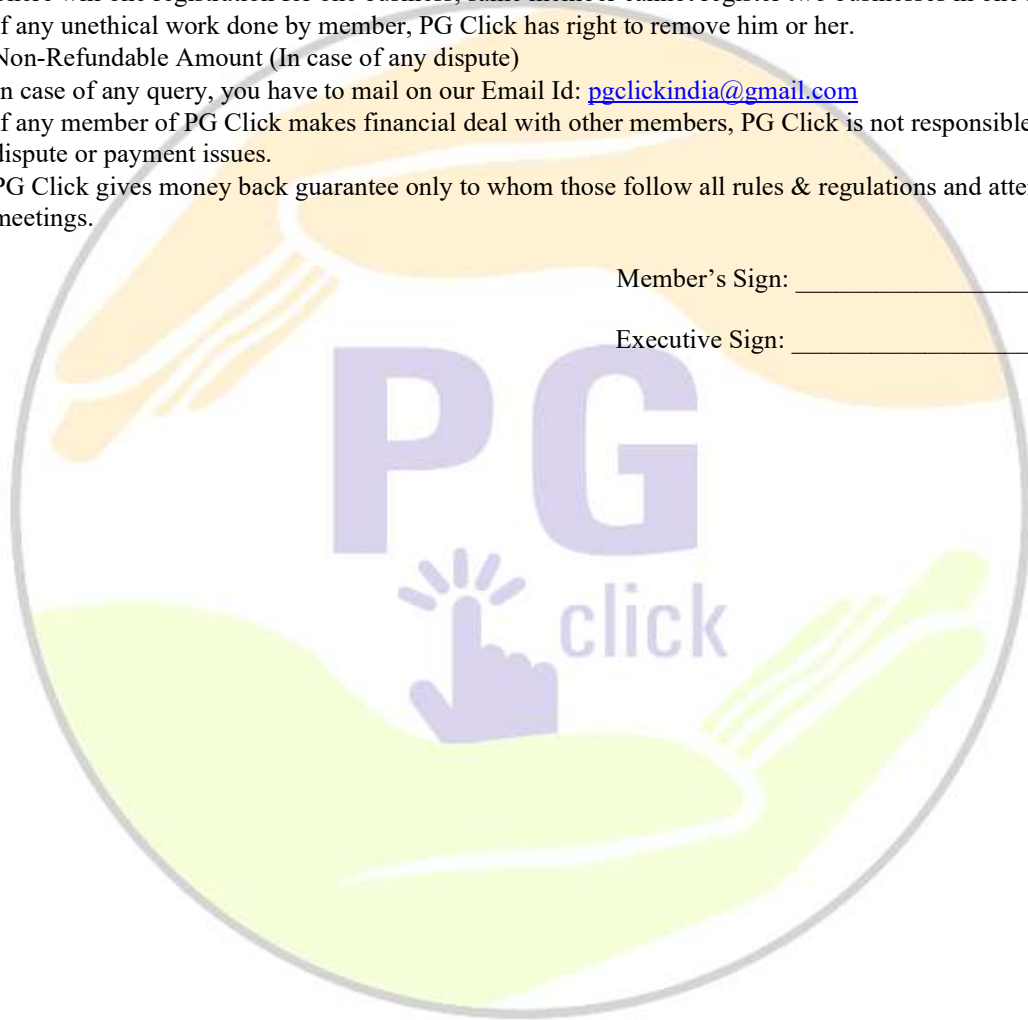
