WHITE'S CREEK MARINA RULES

- Access to White's Creek Marina ramp, docks, and slips are restricted to Boats with current year WCM stickers/tags only (meaning: proper insurance has been supplied and HOA paid). All other access is considered trespassing. This is based on WCM insurance requirements.
- FUELING IS PROHIBITED WITHIN WHITE'S CREEK MARINA.
- Dues and proof of insurance must be presented yearly before the slip is occupied. The
 gate code will be given only after dues and proof of insurance is submitted to the
 Association.
- Parking of vehicles and trailers is restricted to the designated parking areas and a White's Creek
- Marina tag must be on the trailer, or it will be towed at the owner's expense. Tag
 requests should be made via email to whitescreekmarina@gmail.com, with a selfaddressed envelope to be used to distribute the tags.
- Walkways must remain clear of any items. These items include crab traps, bait boxes, storage boxes, toolboxes or any other items that would be deemed an obstruction.
- All boats must be equipped with a working fire extinguisher.
- White's Creek Marina is a No Wake Zone.
- All boats must be secured in the slip to prevent damage to White's Creek Marina and boats.
- Slip/boat owners will be responsible for any damage caused by negligence.
- No boat may exceed more than (3 ft.) beyond the end of the slip pilings. A lift may help achieve the 3-foot maximum extension by allowing a boat to be stored closer to the front decking.
- Swimming in the White's Creek Marina is prohibited.
- Owners/renters are responsible for the safety and conduct of their guests.
- Slip Owners who rent their slips are responsible for providing White's Creek Marina bylaws and general rules to the renter.
- All emergencies, please call 911 The marina address is 155 Naomi Dr., Ocean View, DE
- No marine sanitation devices shall be stored in any boat while in the White's Creek Marina.
- Please avoid pumping holding tank water into White's Creek Marina.
- Cleaning of or disposal of fish or other seafood waste within White's Creek Marina is prohibited.
- Boats may not be occupied overnight within White's Creek Marina.
- Trash must be removed from the marina. White's Creek Marina is a carry-in/carry-out facility.
- Painting of boats or performing maintenance on boats within White's Creek Marina is
- prohibited.
- If damage occurs to the Marina or another boat due to negligence, the owner or renter that caused the negligence is responsible for the repairs.
- No fishing or crabbing permitted from the docks or piers.
- Please supervise children, White's Creek Marina is not a play area and needs to be treated as a dangerous area for children.
