2026 Marine Vessel Registration and WCM Sticker Request

Dear WCM Slip Owner:

THIS YEAR, SLIP OWNERS HAVE TWO OPTIONS FOR PAYMENT AND GETTING THEIR 2026 WCM STICKERS::

#1 - Mail the payment, payment form, required owner registration form, proof of current marine vessel insurance, and enter registration form, if applicable, with a stamped, self-addressed envelope so the 2026 Stickers can be mailed to you, OR

#2 - Go to White's Creek Marina on Saturday, March 14, between the hours of 10:00 a.m. and 2 p.m. submit your dues payment, payment form, required owner registration form, proof of current marine vessel insurance, and reenter registration form, if applicable. LATE FEES ARE DUE FOR PAYMENTS RECEIVED AFTER March 31, 2026.

If you opt for option #1 and your boat is stored /delivered by a shop and you will not be present at launch, please address your stamped envelope for the stickers with the shop address so they can place the sticker on the boat's port side.

Remember that NO vessel - including the motor - may extend more than 3 feet from the last pole in the slip.

The marina must have a current declarations (face) sheet of your marine vessel insurance showing a minimum \$300,000 liability coverage. Liability coverage on owner's boat slip property is recommended by the marina's insurance agency.
