Tibesti Government in Exile – Statement on the Fifth Anniversary Press Release N/01/2025, Saturday, August 9, 2025

On September 14, 2020, we proclaimed the restoration of our state on the ancestral lands of the Tibesti Massif, respecting the territories of Libya, Niger, and Sudan, in full accordance with the UN Charter and the principle of self-determination. We formally notified the UN in sptember 2020 and August 2021, requesting missions to witness the reality on the ground.

The Ndjamena regime an ethnic militia run by drug traffickers is destroying Tibesti's environment, In recent years, the Ndjamena authorities, supported by certain foreign interests have engaged in harmful (Gold and REE), extraction practices in Tibesti, including the use of chemical agents, causing severe and lasting damage to the environment and the fragile ecosystem of our mountains, in response, in October 2018, we established a local governance system (Wogoda) with the dual purpose of environmental protection and community security, responsible for security management, have been appointed to monitor movement into and out of Tibesti in order to protect our land and culture.

This criminal regime survives only through the direct backing of France. French nationals control Chad's security services, advise the militia leader, manage his assets, and dominate the political police. Since 1990, Chad has been a false state administered from France, while aiming to eradicate our people, the drug-trafficking regime of Ndjamena, aided by its European allies, seeks to exterminate our people and seize Tibesti.

History reminds us that both Gaddafi's army and the French army have lose war in Tibesti, the Tubu people have resisted all foreign domination and will continue to do so. Today, 70% of Tibesti is under Wogoda control. Ninety-eight percent of our people demand an independent Tutu state, the Duna Kundudo (Tubu Army) enjoys full popular support.

The Duna Kundudo declares:

Regime militias will be expelled from Tibesti, including from Zouar, Wour, Koru Bugodi, and Aozu airstrip.

Chadians working with the regime must leave by before September, 2025.

Chadians not linked to the regime must register with the Wogoda Office, they will be treated with dignity.

From August 22/ 2025, Libyan border will by close; unauthorized trucks will be seized, air space also will by close.

We call on the United Nations to respect the will of Tibesti's people and to send independent observers.
