INT. _____ **1. Holiday Show Policies & Handout:** I have received or downloaded the Holiday Show handout. I have read the handout thoroughly in its entirety and fully understand all the financial and time commitments. I understand that my child has to be registered in classes in order to participate and perform in the Holiday Show. Students in multiple classes and/or who have siblings that are dancers, will perform in different shows. I will abide by the policies of Take Five Dance Academy, the Holiday Show, Ticket Purchasing and of the location of where our events are held.

INT. _____ **2. NO REFUNDS on Payments/Purchases:** I understand that all sales are final and there are no refunds (Holiday Shirts, Rehearsal Fees and Tickets). Take Five Dance Academy is not responsible for items that are not picked up within 30 days of purchase.

INT. _____ **3. December Tuition Will Not Be Altered & Account Balances Must Be Paid:** I understand that December tuition must be paid. In addition to studio expenses, December tuition covers the cost of paying teachers to be at dress rehearsals and shows. Make-up classes are available for my child for any missed classes. All balances on my account must be paid before my child can participate in the dress rehearsal and performances.

INT. _____ **4. Holiday Performance Attire:** I will pay for all attire required for the performance with the understanding that it will become my property upon completion of payment. This includes the Holiday performance shirt and any dancewear, accessories and/or shoes.

INT. _____ **5. FOR AGES: 6+ SATURDAY Rehearsals:** There is a \$50.00 rehearsal fee (non-refundable) per child. I understand that my child will be learning their dance in SEVEN Saturday Rehearsals. Due to the limited time frame, I know my child CAN ONLY MISS ONE rehearsal (excluding the MANDATORY Saturday Rehearsal on DECEMBER 12, 2026). If my child misses more than one rehearsal, regardless of reason, I understand they will not be able to participate in the Holiday Show and no fees will be refunded.
