NORTHERN PLAINS STAKES: TERMS & CONDITIONS

The following are the terms and conditions of the Northern Plains Stallion Stakes Race for the offspring of those stallions donated to the North Dakota Quarter Horse Racing Association and subsequently sold.

- Donor submissions close by midnight on Sunday, January 26, 2020.
- The NDQHRA auctions the breeding season to the highest bidder.
- **Bidding will start at \$300** unless otherwise indicated by the donor.
- **Winning bids must be paid in full within 14 days** of the end of the auction. Credit cards are accepted via PayPal on the website. If a winning bidder does not pay, they are banned from participating in future auctions.
- All foals conceived in 2020 by said stallion, and foaled in 2020, become eligible to be paid into the 2023 Northern Plains Futurity Race (payment schedule below.)
- If the stallion owner offers a return breeding, it is limited to one year. The Stallion owner or farm must approve any substitute mares.
- If the stallion dies or becomes unfit for breeding prior to covering the mare, the purchaser will receive credit at the following year's sale. No refunds will be given.
- A **bonus of \$500 is paid to the stallion donor** of the winning horse in the 2023 Northern Plains Futurity race.
- Daycare, shipping charges, collection fees and farm fees are between the stallion owner and mare owners. All other guarantees not referred to above, are between stallion owners and mare owners and buyers are encouraged to contact the breeding farms individually concerning additional fees.
- Late payments are double the missed payment, provided payment is made on or before May 1st, 2023.
- If the entry is made AFTER May 1st, 2023, the total amount due at the time of entry is \$2515, which includes all payments plus a \$2000 late fee.
- The Northern Plains Stallion Stakes Futurity Race will take place in 2023 for foals born in 2020.
- The host track and purse will be announced.
- \$10,000 will be added to the 2023 Northern Plains Futurity Race purse.

- I will donate the listed stallion season(s) to the NDQHRA for their 2020 Stallion Season Service Auction. I understand all foals sired by the donated stallion will be eligible to run in the 2023 Northern Plains Futurity and the season must sell for the stallion to be eligible.
- Location of the 2023 Northern Plains Race is TBA.
- If the season fails to sell by January 31st, 2020: **I WILL** **or WILL NOT** **allow the NDQHRA to hold the season out for 30 days**, at a minimum bid of \$300 (or as indicated by the donor.) Stallion seasons will be sold on a first come first serve basis during these 30 days.
- If the season fails to sell, the stallion owner or farm may purchase the stallion for **\$300** to keep future foals eligible. The stallion owner has 60 days from the close of the auction to purchase the season back.
- I understand that as donor, I reserve the right to bid on my own behalf.
- If the breeder fails to get a live foal, **a return breeding IS** **or IS NOT** offered. If offered, a return breeding is limited to one year. If the first mare fails to conceive, the stallion owner must approve any substitute mare.
- **The bidding will start at \$300** (unless a minimum bid is specified by the donor) and the stallion service must sell to qualify foals as eligible.

2019 NDQHRA – YEAR END AWARDS – NOMINATIONS DUE BY 12/31/19

If you wish to enter your horse, to be considered for a year-end award, please submit the nomination form with the name of your horse, amount earned, and proof of earnings by AQHA and or Equibase records, to the NDQHRA. You may attach a separate sheet with this information. To be eligible, the following criteria must be met.

- Points will be awarded for each dollar earned from a recognized track.
- ND Bred horses will earn points the entire racing season provided the owner is a member of the NDQHRA.
- ND owned horses will earn points during the period the horse is registered in a ND residence name, and the owner is a member of the NDQHRA.
- Only paid 2018 members of NDQHRA may submit nominees.
- Please use an official source for proof of race earnings such as Equibase (Equibase.com) or True Form Racing Services (/racewithtrs.com).

NORTHERN PLAINS FUTRITY RACES RULES

1. The Northern Plains Futurity Race is for 2-year-old horses produced by donated and sold stallions in the annual NDQHRA Stallion Stake Service Auction.
2. If the stallion season is not purchased in the auction it can be purchased by the owner. The owner shall receive notice immediately after the auction that their stallion season did not sell. They must pay \$300 within 30 days of the end of the auction to keep their stallion eligible in the Northern Plains Race.
3. The race is 350 yards.
4. A bonus of \$500 will be paid to the owner of the stallion of the winning horse. The bonus is not taken out of the purse and is paid directly from the NDQHRA.
5. All horses must be registered with AQHA (American Quarter Horse Association).
6. If there are 8 entries or less, no trials will be run. The 8 fastest qualifiers advance to the finals. If there are 9 or more entries, trials will be held.
7. The first 8 places will be awarded a percentage of the purse. The disbursement is as follows:

1 st Place: 50%	4 th Place: 6%	7 th Place: 2%
2 nd Place: 23%	5 th Place: 2%	8 th Place: 2%
3 rd Place: 13%	6 th Place: 2%	

8. Entry Fees as follows:

9. Late payments will be double the missed payment. After May 1st the penalty will be \$2000 plus the missed payments for a total of \$2515 which may be paid at the time of entry along with membership dues if they are not current.
10. The association shall deduct 15% from the payments for administrative expenses. The Mare Entry fee shall go directly to the NDQHRA and will not be part of the purse.
11. All owners MUST be a current member of the NDQHRA. Membership dues must be paid throughout the above payment schedule. If the horse is sold, during the payment timespan, the current owner must be a paid member. If they are not, the purchaser may pay the membership dues for any year missed. The NDQHRA membership dues are \$50 per year.



North Dakota Certified Bred Race Rules

1. Horses must be registered with the AQHA and must be certified and stamped ND Certified Bred per the rules of the North Dakota Breeders' Fund Registry.
2. No horse shall be permitted to start in the race until the registration certificate has been filed with the track racing secretary and the horse has been fully identified.
3. You must be a current member, in good standing, of the NDQHRA. Dues of \$50. You cannot enter your horse unless Membership Dues are paid.
4. A non-sufficient funds check will be considered non-payment.
5. 15% of the total payments received will be withheld for association administrative costs.
6. In all ND Bred Races, no more than 8 head in trials. If there are 8 entries or less no trials will be run. The 8 fastest qualifiers advance to the finals. No also eligibles, no consolation. The top 8 winners will be paid.
7. High weights preferred for Maturity. Maturity must have 6 head to run. If 5 or less, the race will be opened to 3 yr. old's - high weights preferred and the late entry fee of \$800 must be paid.
8. If a qualifier is unable to run in finals, he must enter finals and scratch at post time to qualify for last place purse.
9. If you do not enter races by track closing time, you will be unable to run and will not receive a refund.
10. When a result in a dead heat, the heat shall not be run off. Monies shall be split for the dead heat position.
11. State steward's decisions will be final unless deferred to the NDQHRA.
