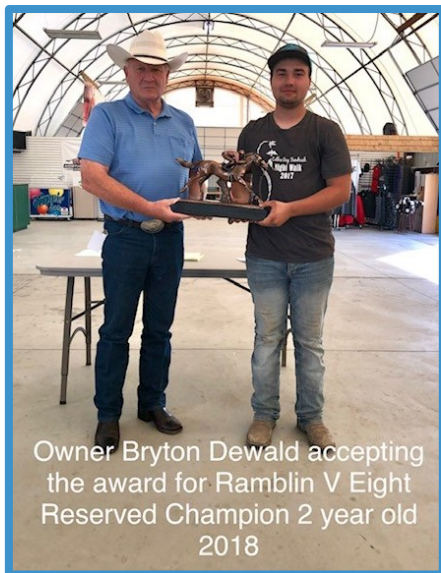

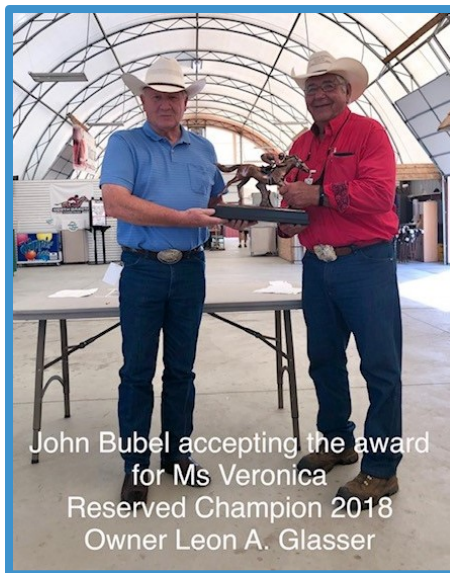

Minutes from the 2018 Annual Board Meeting

President Leon Glasser called the meeting to order at 2:00 PM CST. Present: President, Leon Glasser, Vice President, Randal Schwartz, Secretary/Treasurer: Sally Dasinger and Directors, Sharlene Reuer, Douglas Plummer, John Bubel, Wesley Heinert.

Minutes from the last meeting on December 02, 2017 were distributed. John Bubel made a motion to accept them as written, Wes Heinert seconded. All in favor.

Treasurers report was accepted, and it was decided to have a separate Purses and Administrative QuickBooks Account. The Treasurer will take care of this.

Stallion Auction, Race Rules and Regulations:

- The NDQHRA will continue a "blacklist" for those who receive the winning bid but do not pay for their purchases in the annual NDQHRA Stallion Stakes Service Auction. A notice will be added; Payment must be made within 30 days. If payment is not made, we will proceed to the 2nd highest bidder to see if they still wish to purchase the stallion service.
- Membership in the NDQHRA is a privilege not a right.
- You must be a member in good standing to participate in any NDQHRA races.
- If there is an issue in a NDQHRA race, and if the ND Racing Commission or racing secretary do not make a final decision, the NDQHRA Board will have the final say in how to proceed or the way to resolve the issue.
- If a horse entered in an NDQHRA race, wears a flipping rig, they do so at their own risk.
- If there is a gate malfunction due to a horse crashing through their gate it is considered a non-starter.
- If there is a malfunction in timing, the winner of each heat will be in the final (if 3 trials are held) or the top 2 of each heat and there will be a drawing for the last 2.
- Yearend awards are based on the amount of money earned.

- Payouts will be the same for the Northern Plains Futurity and the ND Certified Bred Races. 8 horses allowed in the final race. Purse payouts will be as follows: 1st =50%, 2nd =23%, 3rd =13%, 4th =6%, 5th thru 8th place earn 2%.

Historic Racing: Due to the drop in ADW donations it was suggested to go in with the ND Thoroughbred Racing Association to lobby for a bill which would allow fundraising machines in businesses in which some earnings would benefit the Fargo Horse Park. It was agreed to help pay for a lobbyist to help get a bill passed in the upcoming legislative session. Motion was made by Randy Schwartz and seconded by Sharlene Reuer. All in favor.

Meeting Adjourned: Moved by Wes Heinert and seconded by Randy Schwartz. All in favor. The time was 4:00 PM.

Minutes from the last meeting on December 02, 2017 were distributed. Sharlene Reuer made a motion to accept them as written and Randy Schwartz seconded. All in favor.

Treasurers report was approved.

Like last year, it was decided to add \$5000 to each purse ND Certified Bred Futurity & Derby Races. A motion made by Randy Schwartz and seconded by John Bubel. All in favor.

Agreed to give a Christmas bonus of \$250 to the secretary/treasurer.

Nominations for 2 director positions: Wes Heinert, Doug Plummer, Kari Buchholz and Mitch Burney. After a secret ballot was taken the winners were Wes Heinert and Doug Plummer.

The annual free birth drawing was held for one entry into the Northern Plains Futurity - \$515 value. Winner was Wes Heinert.

Meeting Adjourned: Moved by Sharlene Reuer and seconded by John Bubel. All in favor. The time was 5:20 PM.
