Results of City Countil Meeting on 4/22/24

There were 2 mobile home related items on the agenda:

Item #13 was concerned with appointing candidates for the new mobile home committee.

Item #14 involved the council vote on a temporary (45 day) moratorium, banning the practice of bringing any mobile homes more than 20 years old to Yucaipa. This item required a vote by the full council and since Chris Venable was absent, the item was postponed until the next council meeting on May 13, 2024.
