In 2000, the company was renamed Purecotz Creations and began producing sustainable textiles. The processed organic cotton was certified by Agreco Germany and SKAL Netherlands.

In 2009, the company changed its constitution from a partnership firm to a private limited company, now known as Purecotz Eco Lifestyles Pvt. Ltd.

In this year we signed up for the WRAP certification, the world's largest independent social compliance program for facilities.

Our 1,50,000 sq. ft. facility integrates all apparel manufacturing and value-added services under one roof, along with a Zero Liquid Discharge (ZLD) system for sustainable water use.

Knit:



Sustainability Steps

Effluent Treatment Plant (ETP)

- Our ETP is designed to treat 10 KLD wastewater. Our ETP scheme has chemical as well as biological treatment followed by Sand and media filter and have 6 sludge bed for sludge drying.
- We are reusing ETP treated water again to processing i.e. in washing.
- We are using 75% recycled wastewater for washing.

Sewage Treatment Plant (STP)

- We have 60 KLD capacity biological sewage treatment plant. Treated water is reused for gardening and toilet flushing.

Waste Management

- We ensure effective waste segregation and data collection on waste generation.
- We send our fabric waste to the recycler.
- We send our hazardous waste to government approved waste management

EMS & Higg Index

- We have implemented EMS in our facility and also, we are registered on Higg portal and have Higg FEM and FSLM account.
- We are monitoring our Sustainability goals thorough Higg FEM and FSLM and improving year on year.


