2019 Pastor's Report

Dear Brothers and Sisters in Christ,

In 2019, after a year of renovations, we rededicated the Sanctuary on February 24. Neil Johnson was able to upcycle some of our old pews and craft them into a beautiful new communion rail. This communion rail was built with the option to remove it when we need a little more space, like for the Christmas Program. A big thanks to all who were a part of the Sanctuary renovation project.

Over the summer, seventeen Grace members (5 youth and 12 adults) traveled to Puerto Rico for an intergenerational mission trip. Together with 58 people from Central Lutheran Church in Edgerton, we saw and experienced how hurricanes have devastated many buildings, but have not extinguished the hope of the wonderful people of Puerto Rico. We helped rebuild and/or seal a dozen roofs, and we helped with the effort to grow and replant native tree species that were wiped out. It was a wonderful learning opportunity for all of us, and we were thankful to be able to serve and build relationships with those we met there.

We had another successful Lenten drama series – Tales of Trees, and another successful Lenten Challenge – helping to support the hurricane-devastated island of Dominica. Bible studies were offered several times throughout 2019, including a Confirmation Refresher Class, a class on Psalms, a class connecting food and faith called "Taste and See", as well as a book study.

Two VBS events were offered this summer, one focusing on serving our community, and the other focusing on God's creation, including a trip to the zoo. Eight of our youth were confirmed this October and are eagerly finding new ways to serve as adult members of Grace. We lost several beloved members of Grace this year, but we give thanks for their lives and their faith, trusting them into God's loving hands.

Ecumenically, we offered "Ashes on the Go" on Ash Wednesday. We again offered a Blessing of the Animals "Crittergy" and brought back the Cambridge Community Thanksgiving Service, which Grace hosted. 2019 has been such an eventful year.

After the resignation of our bishop in 2019, in 2020, our synod will elect a new bishop, through a much more open, informative process so all voters can get to know the candidates. And here at Grace, I can't wait to see how God will guide our 2020 Vision so we can not only see clearly but live into our callings as children of God in this place and time.

2019 Treasurer Report

During the past fiscal year, we implemented new financial processes at Grace Lutheran. In 2019, our congregation instituted a Finance Council, which is currently made up of five members. The purpose of the Finance Council is to adopt strong financial policies and provide financial oversight for the church. As part of this effort, the Finance Council seeks to coordinate financial efforts throughout the organization by including representatives from our collection counters and the Stewardship Committee, while appointing a member to serve as internal audit oversight.

In addition to the adoption of a Finance Council, the Church Council also voted to change the method of our organization's financial reporting. As of January 1, 2020, our church will begin reporting financial information on a cash basis. This is a change from the accrual basis of accounting used in the past. This change was made in an effort to be more timely and transparent with the church's finances. While many members may not notice the difference in our financial statements, we believe this change will provide more up-to-date and accurate financial reporting going forward.

Our organization was running at a net operating loss at the end of November; at that time, the net operating loss stood at (\$1,456.19). Based on strong giving in December, however, the church's finances finished in the black for 2019. From a financial perspective, I encourage congregants to consider using patterned and predictable giving in 2020 – and going forward– to make cash flow and the church's finances more stable throughout the year.

While our church may be in a more stable financial state, total giving for 2019 was down from the previous year. Through October, total giving between General and Special Giving totaled \$289,965.18. This is a decrease of (\$27,519.58) compared to the same time in 2018. The vast majority of that difference can be attributed to fewer donations classified as Special Giving; these donations were likely related to the Renewing Grace Capital Campaign that kicked off in fall 2018.

In regard to *Renewing Grace*, our capital campaign was going strong through 2019. We continue to receive regular donations to pay down the debt associated with recent renovations and improvements. Thanks to your support, our church was able to pay off loan principal totaling \$92,556.13 through December. This included advance principal payments of \$79,000 made in addition to regular monthly loan obligations. At this time, the current principal due on the loan stands at \$121,937.89. By continuing to make donations toward your Renewing Grace pledges, I am confident you will help us pay down this loan sooner than expected, in turn saving the church money toward projected interest expense.

It is my goal as Treasurer to help bring our church into long-term financial stability and to ensure that we do not run at an annual net operating loss in the future. That goal, however, can only be accomplished by the congregation as a whole. With your help, I believe we can get there. We have seen positive signs in terms of pledged giving for 2020. The number of pledges received has increased and total dollars pledged are also up. Still, I encourage all members of Grace Lutheran to give where they are able. Even small donations go a long way when we give as a whole.

I would like to take this opportunity to thank all of those who pledged to our church both in 2019 and for the year ahead. In addition, I am also very grateful for those who donated their time, abilities and efforts to our organization in 2019. It takes help of all kinds to keep our organization running, and we are fortunate to have a community that is generous both with their monies and their talents. We could not be where we are without you.

I look forward to serving as your treasurer again in 2020 and please do not hesitate to contact me with any questions or concerns you may have.

2019 Endowment Committee Report

The Grace Lutheran Endowment Fund was established for the purpose of funding mission work in our community, country and around the world. This mission support is meant to go above and beyond the programs supported through regular offerings.

Members of Grace Lutheran Church can give to the Endowment Fund through bequests; assignments of life insurance benefits; assignments of certificates of deposit; transfers of property such as cash, stocks, bonds and real estate; memorial gifts; charitable annuities; and charitable remainder trusts.

The Endowment Fund is invested in the ELCA Endowment Fund Pooled Trust. The fund provides professional management of the investments with no load or withdrawal fees. There is a 1% annual management fee.

On December 18th, 2019 the Endowment Committee reviewed 2019 endowment fund requests. Committee Members include Phil Vasby, Tom Jensen, Amy Simdon, Robert Pratt and Todd Tatlock. The committee received requests to fund four (4) programs this year and all agreed to fund all of them as follows, below, with 2019 Endowment funds of \$1,887.58.

The interest that the fund earns is distributed each year according to the by-laws of the Endowment Fund. The guidelines are:

- 20% minimum to capital improvements or debt reduction
- 20% minimum to community outreach
- 20% minimum missions
- (40% maximum for any one of the above)

2019 Pastoral Housing Account

The Pastoral Housing Fund was originally established by using the profit from the sale of the parsonage. Currently, the money is invested with the ELCA. There were no changes to the account in 2019; the current balance is \$48,220.39

2019 Outreach Team Report

Once again, we surpassed our Lenten Challenge goal! Many thanks to everyone who contributed to the "Do a World of Good for Dominica" campaign; the final amount given to Lutheran World Relief was \$2,142!

Kirsten Fryer, the missionary we have been supporting in Egypt, completed her 6 years of faithful service on June 30, 2019. Since July, we have been supporting two new ELCA missionaries: Rev. Rachel Eskesen & Zachary Courter. They will be coordinators for the youth and adults in the Global Mission Program in Hungary and Serbia.

We hosted Chaplain Todd Marcotte, who gave us an insight into the spiritual life, resources, and programs provided by inmates of the Dane County Jail. In October, we held a cookout fundraiser for the Madison Area Jail Ministry at the local Piggly Wiggly and, with the help of Thrivent, we raised over \$1,000 for the jail ministry.

We decided to move God's Work. Our Hands. to the Spring, when more tasks outside can be done.

This year, we sent 104 quilts, 150 school kits, 50 baby care kits and 4 fabric kits to Lutheran World Relief; this was far more than we sent the prior year. Thank you to all who donated in some way to this worthy cause.
