**Company Information:** These terms and conditions apply to Nottinghamshire Funeral Service Limited, which may trade simply under the name NFS, referred to elsewhere in the document as "the Company" being the legal entity. The ultimate owner of Nottinghamshire Funeral Service Limited (08915233) is Mr Bernard Leaper.

**Crematoria Price List April 2026:** This table is for prices charged for an adult funeral service (18+ years of age) within a 35 mile cortege journey from our Head Office 11A Bexon Court, Foxhill Road East, Carlton, NG4 1SQ. All prices are in pounds sterling (GBP) unless indicated otherwise. Please note these prices are set by the Crematoria, not NFS.

**Terms of Business:** Each client will receive a price list detailing both company & crematoria pricing, along with a written estimate and right to cancel information, which will be agreed between the client and the company.

**Final Charges:** Final charges may differ from Estimate as this may include third party charges or additional goods or services. Estimates are calculated manually and any mathematical errors will be corrected in the final Invoice.

**Payment Terms/Charges:** A payment may be required by the Company prior to the service date, depending on goods and services required. Full payment of any outstanding charges is due upon presentation of the final Invoice (usually within seven days of service).

The Client is personally liable for making payment of all Company charges and disbursements and whilst the Invoice may be forwarded to a nominated person, when the Company is instructed to do so, this does not discharge the Client of their liability of any and all outstanding charges.

The client remains liable for any outstanding balance which is not discharged by the other nominated person; DWP or whoever is administering the deceased Estate. In any case the Client is responsible for ensuring that payment is made within the payment terms stated above.

Where the Company has made an estimate of the anticipated DWP social fund payment, this is on the basis of the information provided to it, which may be inaccurate or incomplete. The Company is not responsible for any difference between the actual and anticipated payment and when there is a shortfall the Client remains ultimately responsible for making up said shortfall.

There is no surcharge for payment via Credit/Debit Card. A bank transfer can be accommodated. Cheque payment is upon agreement with NFS Management. The Company will make a reduction of £100.00 if the full estimated amount and known disbursements are paid before the service date.

**Late payments/Overdue Accounts:** In the event that payment is not received within thirty (30) days from date of Invoice, the Company reserves the right to: apply 2% to the outstanding balance and apply an additional 2% every additional calendar month the balance remains outstanding; refer the matter to Debt Collectors or Solicitors (including all fees and charges incurred in doing so) and prepare the matter for court if deemed necessary including all legal fees; court fees and associated charges being paid by the Client.
