

Hello Nob Hill Indivisibles,



This coming Monday, June 17, the Albuquerque City Council will be voting on two measures for Ranked Choice Voting (RCV). RCV is the process whereby a run-off is built into an election in which people rank the candidates according to their preference rather than just their one favorite candidate. One measure will be for Albuquerque to adopt RCV by ordinance. The other will be to put RCV on the ballot for voters to approve this November. Indivisible Nob Hill has been coordinating with Common Cause to promote RCV. We want RCV as soon as possible, and we favor the City Council enacting RCV by ordinance, rather than putting it on the ballot.

**INH is MOVING OUR ENTIRE MONDAY MEETING to the CITY COUNCIL on Monday in order to support RCV as the ORDINANCE. Our planned, speaker, Eric Shimamoto wants to do that too and will speak to us on July 15.**

The main reasons for supporting RCV are:

- RCV ensures the election of candidates with broad backing and generally increases turnout among the voters
- RCV avoids the phenomenon of vote splitting when there are multiple candidates and two or more candidates with similar views
- RCV avoids the need for and expense of holding a separate run-off election

The reasons for supporting an ordinance over a ballot measure:

- We could have RCV for this fall's City Council elections and avoid the expense of an actual run-off election
- If we do have an actual run-off election, now that our regular election is held in November (as opposed to October), the run-off would be held in December, when a significant drop in the turnout can be expected
- The ballot measure would mean a significant expense in itself and would likely be subject to a lot of money being injected into the campaign against it

We have four solid votes for the ordinance: Councilors Benton, Davis, Winter, and Gibson. A big turnout on Monday could put a fifth councilor over the top. If you attend, you have two opportunities to speak for two minutes. One is during the public comment period that begins at 5:30, and the other is when RCV is addressed by the Council. We don't know when RCV will be addressed. So, if you have limited time, please sign up to speak during the public comment period.

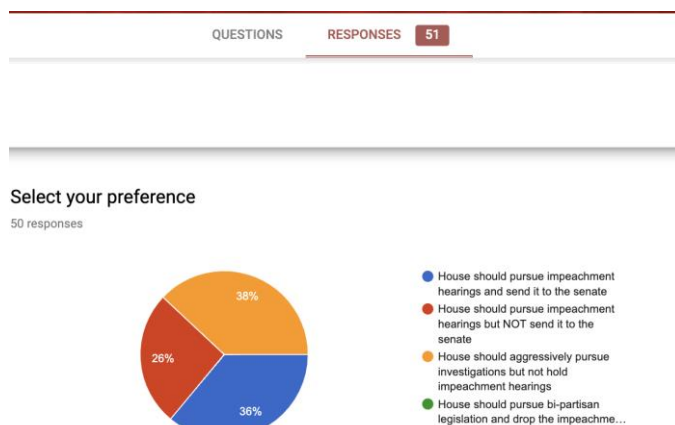
### 1. Foreign entities interfering in our elections is an attack on our democracy.

Cooperating with those attacks, besides being highly unethical and thoroughly unpatriotic (if not traitorous), could be illegal. It's imperative that Congress **pass the Foreign Influence Reporting in Elections (FIRE) Act**, a bill recently introduced by Senator Warner, which would require campaigns to report foreign attempts to interfere in elections to the FBI and the FEC. **Call our MoCs and tell them to pass this act.**

**2. House Democrats are very likely to act on legislation to lower prescription drug costs this summer**, and they are currently considering two competing proposals for doing so. Rep. Lloyd Doggett's **H.R. 1046 is a much stronger approach than the alternative**; click [here](#) to learn more about why it's the right policy to solve this problem, then make a call to tell your Rep and ask them to co-sponsor this critical legislation.

**3. Tell the Dem Presidential candidates to take the 2020 pledge.** The pledge calls on the now 23 presidential candidates to treat the primary as **an exchange of ideas while respecting their opponents and to immediately support the eventual nominee**, working together to "do the work to beat Trump." **Send a letter and/or tweet to all the candidates** and ask them to take the pledge. ## Despite it all...

It took the U.S. 40 years to reach 1 million solar installations. It only took three to get to 2 million. According to data in a report released by Wood Mackenzie Power & Renewables and the Solar Energy Industries Association, **the U.S. now has more than 2 million solar installations -- double the number we had in 2016.** That makes the U.S. the third nation to

reach the 2 million milestone, joining Australia and Japan. And New Mexico is in the top 12 states who are using solar power.

**Oregon Governor Kate Brown signed the National Popular Vote bill last Wednesday** -- this makes Oregon the 16th jurisdiction to enact the bill into law. Meanwhile, the Maine House passed the bill 77-69 on Wednesday. The Maine Senate had originally passed the bill by a by a 19-16 margin, and then re-passed it by a 21-14 margin. **This means the Bill has 196 electoral votes of the 270 needed to enact the bill into law**, this include 5 small jurisdictions (Delaware, Hawaii, Rhode Island, Vermont, and the District of Columbia), 7 medium-sized states (Colorado, Connecticut, Maryland, Massachusetts, New Mexico, Oregon, Washington state), and 4 big states (California, Illinois, New Jersey, and New York).
