Actions

National actions: Call our MoCs, for contacts, click [here](#).

1. A rule that protects the wildest parts of our national forests is under attack. First, Alaska got the Trump administration to consider exempting the Tongass National Forest from the Roadless Rule -- which keeps destructive logging, mining, road building and more out of the Tongass' centuries-old wilderness. Now another state is following suit. The governor of Utah met with U.S. Agriculture Secretary Sonny Perdue to discuss exempting Utah's forests from the Roadless Rule. The Roadless Rule protects forests in 39 states, **call our MoCs and tell them to pass the Roadless Area Conservation Act.**

2. During the 2016 election there was a clear attempt from foreign governments to interfere in our elections – most notably from Russia. Each of our intelligence agencies resolutely concluded that attempts were made, but little has been done to prevent it from occurring again. House Rep. Zoe Lofgren introduced the **Securing America's Federal Elections Act (SAFE Act)** to ensure that voting equipment is safe and secure from attempts to undermine the outcome of our elections. Contact your Rep and ask them to co-sponsor this Act.

3. Momentum is building for the Green New Deal -- a visionary plan to fight the climate crisis while creating jobs and addressing inequality. But **Trump's NAFTA 2.0 is putting all those goals at risk.** Call your representatives and ask them to defend workers, our climate, and communities by saying **no to Trump's NAFTA**. 4. The **Agricultural Research Service (ARS)**, often referred to as “one of [our government’s] best kept secrets,” has done cutting edge **research on the impacts of the climate crisis on food production**. Now the agency has **mysteriously fallen silent instead of publicizing its scientists’ climate-related findings**. Demand House Agriculture Committee Chair Collin Peterson and the House Agriculture Subcommittee on Biotechnology, Horticulture, and Research to hold hearings on suppression of research. **Send a letter to all the committee members** via the Action Network, click [here](#).
