
Join us and thousands of people in communities across our country to protest the inhumane conditions faced by refugees in the United States.

2. Airlines like Southwest generate over 5 million tons of cabin trash each year. But things are changing. In January, Portuguese airline Hi Fly flew the world's first plastic-free flight. And Air New Zealand and Ryanair are phasing out single-use plastic entirely. Social Justice in your hood.

New Mexico's Immigrant Law Center is working to change the face of the legal profession. The most current numbers from the American Bar Association show that 85% of lawyers nationally are white. So, NMILC has developed the Next Generation of Social Justice Lawyers leadership program to bring critically needed legal aid to immigrant communities while promoting leadership development for communities of color and immigrants who are pursuing a legal career. 1. You go girl! The New Mexico Children, Youth and Families Department (CYFD) has withdrawn a proposal **to limit eligibility for child-care assistance to parents earning**

160% or less of the federal poverty level — down from 200% enacted in May, following the settlement of a class-action lawsuit against the agency's previous leader. The **Governor's Office and CYFD officials had said they hoped to restore the higher family income cap of 200%** of the federal poverty level by 2020. Last week, Lujan Grisham said that poverty in New Mexico must be "dealt a death blow". In the statement issued Wednesday, she said, "Universal child-care assistance in New Mexico is my unconditional goal", adding, "To settle for anything less would be a disservice to the families and children of this state".
