## **ORDINANCE NO. 02-10**

AN ORDINANCE OF THE TOWNSHIP OF BROWNSVILLE DEFINING DISORDERLY CONDUCT WITHIN THE LIMITS OF THE TOWNSHIP OF BROWNSVILLE, FOR PROVIDING PENALTIES AND VIOLATIONS.

**BE IT ORDAINED AND ENACTED** by the Board of Township Supervisors of Brownsville Township, County of Fayette and Commonwealth of Pennsylvania.

**SECTION 1**. That disorderly conduct within the limits of Brownsville Township is hereby defined in all cases where any person:

- **a**. Shall be guilty of a breach of the peace, vagrancy, engaged in fighting or inciting others to fight, or engage in any act tending to imperil the personal security or safety of any person or to endanger or injure property within the Township.
- **b.** Shall use loud, boisterous, profane, blasphemous, indecent or immoral language upon or near any of the public highways or public places, or in a manner as to annoy residents in the neighborhood, or to make any unseeming noise or disturbance to the annoyance of the residents nearby.
- **c.** Shall commit any act of lewdness or public indecency, or exposure of the person, or to become intoxicated.
- **d.** Shall loaf, loiter or stand upon any of the sidewalks or the public highways or places, so as to interfere with the full and free privilege of residents and travelers.
- **e**. Shall set up, maintain, open or conduct any gambling place or device; immoral show, entertainment or exhibition, unlawful drinking place, resident of a house of prostitution, or be gathered in or participate in the operation of the same, or to be a patron thereof.

- **f.** Shall carry concealed any deadly weapons, unless authorized by law, or to discharge any gun or firearm unless in defense of person or property; to throw on or into any street or highway any stores, snowballs or other materials; or to raise any false alarm of fire.
- **g.** Shall interfere with the police, resist arrest or fail to render assistance to any police officer when called upon by him; or to tamper with, destroy or otherwise interfere with any lights, signs, guardrails or other property or materials placed in business places by the Township or any of its officials.

**SECTION 2**. If any person or persons shall be guilty of disorderly conduct in any of several matters as above defined, upon conviction thereof, before the magisterial district judge, or any other magistrate, said person or persons shall be subject to the payment of a fine of not more than \$300.00 Dollars, and in default of payment of such fine, shall be imprisoned in the county jail for a period not exceeding thirty (30) days.

**SECTION 3**. The Secretary is hereby ordered and direct to cause this ordinance to be published.

**SECTION 4.** This ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect 30 days from and after the date of its final passage and adoption.

**SECTION 5**. All ordinances or parts of ordinances inconsistent herewith being and the same are hereby repealed.
