BROWNSVILLE TOWNSHIP FAYETTE COUNTY, PENNSYLVANIA

ORDINANCE NO. 03-10

AN ORDINANCE PROHIBITING CHILDREN NOT HAVING REACHED THE AGE OF EIGHTEEN (18) YEARS TO BE AND REMAIN IN OR UPON THE STREETS, ALLEYS, PARKS, OR PUBLIC PLACES IN THE TOWNSHIP OF BROWNSVILLE AT NIGHT AFTER THIRTY (30) MINUTES PAST 10 O'CLOCK P.M. OR FOR CHILDREN NOT HAVING REACHED THE AGE OF TWELVE (12) YEARS AFTER 9 O'CLOCK P.M., UNLESS ACCOMPANIED BY THOSE PERSONS HEREIN PROVIDED.

BE IT ORDAINED AND ENACTED by the Board of Township Supervisors of Brownsville Township, County of Fayette and Commonwealth of Pennsylvania.

SECTION 1. It shall be unlawful for any child, male or female, not having reached the age of 18 years, to be or remain in or upon the streets, alleys, parks or public places of the Township of Brownsville at night after 30 minutes past 10 o'clock P.M., unless such child is accompanied by a parent, guardian or other person having the legal custody of such child, or any child, male or female, who has not yet reached the age of 12 years to be or remain in or upon the streets, alleys, parks or public places in the Township of Brownsville at night after 9 o'clock P.M., unless such child is accompanied by a parent, guardian or other person having the legal custody of such child.

SECTION 2. Any child not child having reached the age of 18 years found upon the streets, alleys, parks or public places in the Township of Brownsville, or any child who has not yet reached the age of 12 years found upon the streets, alleys, parks or public places in the Township of Brownsville

in violation of Section 1 of this ordinance shall be taken into custody by the appropriate police department, and his or her parents, guardian or person having legal custody. If any parent, guardian or other person having the legal custody of said child shall again allow him or her to be or remain on said streets, alleys, parks or public places in violation of Section 1 of this ordinance, said parent, guardian, or person having legal custody of said child so offending shall, upon conviction thereof before the magisterial district judge or other magistrate be sentenced to pay a fine of not less than \$100.00 for the first offense, \$200.00 for the second offense; \$300.00 for the third offense; \$400.00 for the fourth offense; \$500.00 for the fifth offense; and \$500.00 to \$1,000.00 for the sixth and subsequent offenses thereafter in addition to costs; and upon failure of the convicted party to pay said fine, a warrant will be issue for their arrest.

SECTION 3. The Secretary is hereby ordered and direct to cause this ordinance to be published.

SECTION 4. This ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect 30 days from and after the date of its final passage and adoption.

SECTION 5. All ordinances or parts of ordinances inconsistent herewith being and the same are hereby repealed.
