**Travel that is more than 125 miles requires a hotel stay either the night before or day of service (whichever artist prefers) and has a minimum of 6 people per artist booked.*

It is the client's responsibility to advise the artist if they have any allergies. Client agrees and understands that all artists are independent contractors. Clients further agrees to indemnify and hold harmless MAKEUP BY COURTNEY PAIGE, affiliates, officers, agents, employees, consultants, contractors or subcontractors from any claims of liability, losses, damages, or any expenses whatsoever as a result of any claims, demands, damages, costs or judgments, including but not limited to, claims based on negligence against it, that may arise in connection with the services performed by an independent contract artist. This agreement is intended to be an addendum to any previous conditions, releases or holds harmless agreements, in written form, verbal or manually communicated between MAKEUP BY COURTNEY PAIGE and its clients in connection to services. Therefore, clients release MAKEUP BY COURTNEY PAIGE and its representatives and subsidiaries of all claims of injury, seen or unseen that may occur as a result of any service including but not limited to makeup application/hair services. Client signing will be the responsible party for the total fee of the service package (Both self & party, if individuals listed as payees are unable to tender funds on the day of the event.) All the rates are based on the information stated in this contract (date of event, number of parties, traveling location, time of event, makeup/hair style).
