- Beary Landscaping maintenance contract has ended: 2022-2024
 - Explored other landscaping bids that resulted in no responses or significantly higher bids
 - Despite an increase YOY, we will be signing with Beary again 2025-2028
- Mulching to continue as needed laying down less mulch per tree to avoid mounding
- Continue to remove and replace diseased and dead trees
- Trimming along Wolf Road and Main Entrance
- Refresh front entrance Landscaping and lighting
- The Village of Frankfort is responsible for the maintenance of parkway trees
- Autumn Fields Spring Cleanup Saturday, April 26, 2025
 - Village of Frankfort encourages residents to clean up our community 9:00 AM 11:30
 AM (Volunteer hours for high school students in the subdivision)

Architectural Review Committee Update

- When you need a permit from the Village of Frankfort, you will need an ARC approval letter to give to the Village with the permit request
- It is HIGHLY recommended that you have the ARC approval letter to turn in with your permit paperwork so that it does not get separated
- To obtain an ARC letter, the <u>homeowner</u> must contact <u>arc@autumnfields.net</u> with:
 - Homeowner's name, address and phone number
 - Contractor company name, contact person and phone number
 - Description of work to be done
 - Brand of product and color choice
