Ch. 53-10 North Dakota State Law

Hours of barn operation 8:00 am - 8:00 pm*

*On holidays, show days and weather, this schedule may be adjusted by management.

As a working barn you may get dirty ... wear appropriate clothes and shoes (no sandals, flip-flops, etc.)

1. Do not knock, peek your head in, shout through the door, etc., on the private residence door unless it is an emergency (e.g., horse colic, injured or bleeding animal).
2. All volunteers will receive equal opportunity and treatment throughout recruitment, appointment, training, and service.
3. NO one is allowed in the barn without supervision unless they have become an approved volunteer or visitor.
4. NO one is allowed in the barn without supervision unless they have become an approved volunteer or visitor.
5. There will be no reimbursement of funds for supplies purchased without prior approval from the Board.

6. Although we greatly appreciate all efforts made by volunteers on behalf of PJR, the Board must first approve all actions, correspondence, and solicitations.
7. Volunteers and Visitors may only handle horses after they have been orientated and passed to an approved volunteer, and they may only handle horses that fall into their skill level unless supervised.
8. DO NOT FEED any animal anything without direct approval as some animals may have special needs or dietary restrictions. Only Scheduled Feeders are authorized to feed. Please ask a volunteer or employee first.
9. Turn OFF (!!!) the water by the hose and pump – it leaks otherwise.
10. Medications or drugs may ONLY be administered with the approval of Connie.
11. ANY and ALL veterinary/medical questions go directly and only through Connie. DO NOT call the vet to inquire about PJR animals. You are NOT authorized!
12. Do NOT open any stall door, gate, latch, etc., without prior permission.
13. Do NOT enter any stall or pasture where there is a horse without permission. Always close the gate immediately behind you.
14. Do NOT handle any animal until you have been authorized.
15. Alcohol/drug use when volunteering at DCHR will NOT be tolerated.
16. NO rough housing, screaming, loud noises, or profanity allowed.
17. All equipment must be cleaned and put back in its proper place.
18. PJR is not responsible for advice given by volunteers.
19. All visitors and volunteers must sign a waiver agreement and release paperwork before riding any horses on or off PJR property.

Barn Specifics

- Respect everyone, property, and equipment
- Horses must be always on halter and lead rope and with handler if doing exercises or working.
- When riding horse must be always under control by rider.
- When multiple people are in barn with horses at the same time, respect of each other's space will be maintained for safety and respect purposes.
- If your horse poops while under your care, you must clean it up.
- Please clean up after yourself and your horse. Don't leave your trash and equipment for someone else to clean.
- KEEP TACK AND FEED ROOM CLEAN – I am not your maid!
- Persons under the age of 18 may not ride unsupervised. It is HIGHLY recommended that no one ever rides unsupervised.

- Children under the age of 12 must always have parent supervision. Parents must be on the property.
- No guns (including any guests that accompany you). The owners will carry when needed due to coyotes.
- Do not climb on fences or gates. If you notice any loose fencing or broken area, please Rob and or Connie immediately.
- If you or your guest break something at the barn, please contact Rob and or Connie immediately. Together we will come up with a plan with how to fix it or replace it.
- Please Park on the gravel and do not block the circle driveway.

- Do not borrow something that is not yours. If it doesn't belong to you DO NOT touch it!
- Please do not feed any treats to a horse other than your own or without permission from the owner.
- Any accident or injury to a person or horse must be reported immediately to Rob and or Connie. An accident report must be filled out.
- No parties will be held on the property without consent from Michael and Jennifer. There will be no birthday parties held at the barn.
- Please do not bring your horse up to the house or into the yard.
- All gates are to remain closed at all times (except when passing through). Please double check that all gates are closed and locked.
- Horses are to remain on lead rope when outside of the barn. Horses are not permitted to free roam.
- Please do not install any items in or on the stalls without permission (fans, hooks, Jolly Balls/toys).
- Do not remove any supplies for any reason.
- If you use the last of something, see if there is more in the shed, fill the item up. If not, notify Rob and or Connie immediately.

Be respectful, kind, and considerate to others. Be courteous, patient, and open-minded. We do expect you to be willing to learn and enjoy yourself. PJR is a teaching environment with something to offer the young, the old, the physically/mentally challenged, the animal lover, and the people who admire from afar.
