### **Surrender Rights**

By signing this document, I understand that I am giving up forever all rights to, titles to, and interests, regardless of the delivery or non-delivery of registration papers, to the above animal voluntarily. I further understand that all future decisions regarding the placement of this animal will solely be those of Pride & Joy Rescue. I also understand if this animal is found to be unsuitable for placement for reasons determined by Pride & Joy Rescue and/or a licensed veterinarian that the animal may either be retired at Pride & Joy Rescue or humanly euthanized. Lastly, it is understood that the surrendering party shall hold Pride & Joy Rescue and all its officers, directors, employees, and volunteers harmless from any claims of damage, injury, or acts of negligence arising from this surrender.

This is a legally binding document for the irrevocable surrender of an animal for placement in an adoptive home by Pride & Joy Rescue. Please read this document carefully and thoroughly before signing. Take as much time as you need to consider this decision.

A minimum surrender fee of \$400 is required.
