**NOTE:** If your pet has been sick and currently vomiting or diarrhea, we will be unable to daycare or board your pet. If your pet has an accident, there will be a \$25.00 charge per accident. All pets will have to be contained in a separate yard while the accident is being thoroughly disinfected with hypochlorous acid, which kills canine parvo, hepatitis virus, salmonella, distemper, MRSA, Staphylococcus, E. Coli, bacteria, fungi, and giardia. All playtime comes to a halt when such accident should occur, we will ensure no other pets encounter the substance. As a Veterinary Technician, I am aware that it could be a dietary change or slight flu, but as a precaution, we act swiftly. However, we do not have the equipment to identify a parasite. Owner will be notified after clean-up.

## AGREEMENT:

- Owner agrees to be solely responsible for any and all acts of behavior of owner's pet(s) while in the care of Barks and Purrs Pet Daycare
- Owner specifically represents that the pet has not been exposed to distemper within 30 days prior to boarding/daycare.
- Owner agrees that the pet(s) shall not leave Barks and Purrs facility until all charges are paid in full.
- Owner specifically represents that they are the lawful and valid owners of the pet, free and clear of all liens and encumbrances.
- Owner agrees that in the event the boarding/pet daycare charges are not paid when due in accordance with this agreement, Barks and Purrs may exercise its lawful rights upon ten (10) days written notice by delivering such notice via first class mail to owner's address. A pet that is unclaimed at Barks and Purrs for beyond ten (10) days of its discharge date is considered abandoned and will become the property of Barks and Purrs Pet Daycare and More.
  - Note: Every effort will be made to contact the owner(s) if abandonment is an issue. If for any reason the pet is not being picked up on scheduled dismissal date, owner shall contact Barks and Purrs immediately to extend the pets stay and will pay the additional charges based upon the aforesaid daily rate.
- Daycare pets picked up past closing hours of 6pm will be charged an additional \$5.00 for every 15 mins late. Late pickup cannot exceed 6:30 pm otherwise pet will become and charged as a boarder. Our operation hours are Monday to Friday 7am to 6pm, Saturday 8am to 2 pm, excluding Holidays.
- Boarding pets picked up after 2pm will be charged daycare half-day daycare fee, pets picked up after 4PM will be charged a full daycare fee. Pets picked up at 6pm will be charged a full day of boarding.
- Overnight assessment pets are scheduled to be picked up before 10am the following morning. Pets picked up after 10am will be charged half-day daycare fee. Pets picked up after 4pm will be charged a full daycare fee. These additional fees, if deemed, are in addition to the assessment charge of \$35.00.
