

The letters are descriptive of camp life, regimental maneuvers and nearby battles, and also include queries about life back home. The letters from Peter VanArsdale are dated October 1862 to March 1863. Peter VanArsdale died of typhoid fever on 7 April 1863 in a regimental hospital in Belle Plain, Va.</p> <p>Also in the collection is a letter written to Peter's parents by Isaac Davis, a fellow soldier informing them that Peter had taken ill with camp fever as well as a response, presumably from Peter's parents, inquiring about Peter's health and requesting that his body be sent home to Somerville, N.J. if he died.</p> <p>The last two items in the collection are an 1886 letter written by Jane M. VanArsdale (Peter's mother) inquiring about a pension and a receipt to P. VanArsdale signed by E.B. County members of the Tunison/Ten Eyck families. -Folders 1-8 are deeds and a mortgage belonging to the Ten Eyck/Tunison family which appear to be for the same parcel of land in Somerville, Bridgewater Twp., routinely described as the "premises conveyed to Peter T. Tunison by Isaac Southard and wife by deed dated May 5th, 1843." In the quit claim deed of Eliza T.E. Tunison, the property is referred to as the "dwelling houses and premises situate on Bridge and South streets in the village of Somerville." Also included is a photostat of the will of Edmister Moore dated 1780, and the last will and testament, and estate inventory of Jane B. [Brokaw] Ten Eyck, widow of John Ten Eyck, probated 1875.

-Folder 9 is the ciphering book of Sarah Ten Eyck, ca. 1820s.

-Folders 10-15 consist of correspondence, a concert program, and a funeral card.

-Folders 16-19 include the penmanship workbooks and school reports written by Elizabeth Long in the early 1890s.


Folder 20 is a scrapbook of newspaper clippings of family deaths and other notable events, many related to the Long family. Also included are letters; and an ode written upon the occasion of Nellie Tunison's death.

-Folder 21 is an invitation to a dedication of the First Somerset Hospital which was placed loose in the scrapbook. Inside the invitation were found two dried flowers.

-Folders 22-29 contain family history research and correspondence. Folders 22 and 23 are the DAR applications, documentation and related research for Elizabeth Long Crouch as a descendant of the patriot, Major Dr. Garret Tunison (1751-1837), a surgeon in the N.J. 2nd Artillery Regiment commanded by Col. Lamb. The last letters of correspondence in Folder 29 are dated 1983-84, which confirm that Elizabeth Long Crouch, while the creator of the collection, could not have been the donor.

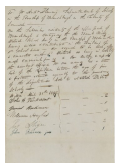
The second series is comprised of photographs of the Tunison, Long and allied families. The series consists of cabinet cards that were placed in a Victorian photo album as well as numerous loose cabinet cards, cartes de visites, and other photographs of varying sizes.

-Folders 30-57 contain the cabinet card photos from the album which was dissembled and the original order of the photos retained. The photos were accompanied by slips of paper, #1-#29, naming the subject of the photo if known, and adding identifying information. #13 was assumed missing as there was a blank page found between #12 and #14.

The manuscripts consist of two subjects:

The first is the proposed union of schools accompanied by petitions for and against the union. The second is a number of Reports of the Superintendent of Schools and Accounts of the Branchburg School District. The Superintendent Reports include funds paid for schooling of poor children. Most reports are signed by A. Fleming; the rest are unsigned. Also included in the collection is a request from the Branchburg Township Committee to the Union School District to pay monies owed to teacher, William H. Jeliff.

It appears that the School Districts in questions were ultimately united. From the Superintendent's Report for year ending 10 Apr 1848, "Their (six) has been two Districts united at the North Branch and in Bridgewater with one in Branch Burgh also Districts No. 1 & 2 known as Milltown & Center have been united . . . "

This collection would be of interest to one researching the history of the schools in the Branchburg/Bridgewater area of Somerset County, N.J. as well as those interested in Superintendent Andrew Fleming and/or residents whose names appear on the school petitions. The legible names from the petitions have been added as search terms in order to aid genealogical researchers.
