The Glen Burnie Recreation Association will start its 71st year of dance classes beginning the week of September 21st. The program is open to anyone who is at least 3 years of age by September 1, 2026. Regular classes are one hour long and include ballet and tap instruction. Jazz instruction is included for those seven and older. Mail in registration is from now until August 26th. **Our preferred method of registration is mail in or drop off, in our secure locked mailbox on our front porch.** If you must register in person, walk-in registration is at the studio on Wednesday, August 26, 2026, from 5:00 pm to 7:00 pm. All information is subject to change. Please know, only dancers and staff are allowed inside our building.

This year's tuition for regular dance classes is **\$225** per student which reflects a discount for cash or check. Tuition is **\$230** per student using a credit card. The full amount for each student must accompany the registration form. Tuition includes a digital download of our recitals.

Tuition is non-refundable. No dancer will be placed in a class without payment. There will be a \$30 charge for returned checks. Checks should be made payable to GBRA. Classes must have a minimum of 6 dancers, if the minimum is not met classes may be reassigned.

Specialty classes are being offered in addition to regular dance classes:

Dancers must enroll in a regular class in order to register for any of the specialty classes.

Pointe class (45 minutes) is offered for those 13 years of age and older with at least 3 years of ballet training. Pointe shoes are not to be purchased without the approval of the instructor. Tuition is **\$100.00** (cash or check) or **\$105** (credit).

Pom classes (30 minutes) will be offered for 7-10 years old, middle school and high school and above. Tuition is **\$100.00** (cash or check) or **\$105** (credit). Information will be given out at parent day regarding specific shoe requirements.

Hip Hop classes (30 minutes) will be offered for 9-10 years old, middle school and high school and above. Tuition is **\$100.00** (cash or check) or **\$105** (credit). Black jazz shoes are required for Hip Hop classes.

Lyrical classes (30 minutes) will be offered for those in Middle School and above. Tuition is **\$100.00** (cash or check) or **\$105** (credit). Lyrical shoes may need to be purchased for recital.

General Information:

Each dancer **MUST** wear leotard and tights or leggings. No athletic shorts. All dancers need leather ballet shoes with elastic straps (pink for females and black for males) and black tap shoes. Black jazz shoes are required for all jazz classes. Dancers must have all required shoes by November. Dancers may bring their own water bottles. Please keep your dancer home if they feel ill.

We will greet your dancers at the door. Dancers will enter in the front door (porch) and exit out of back door. When dropping off, wait for your child to enter the building before you leave. If they are late, come to the BACK door and ring the bell. Please be prompt in bringing and picking up dancers. We encourage all dancers to use the bathroom BEFORE coming to class.

GBRA will determine closures due to weather or emergencies. Please call the studio after 2:30 p.m. at 410-768-1058 for information regarding closures.

Fundraisers: We need everyone to support our fundraisers to continue our dance program every year – see the calendar for all fundraisers and please make plans to contribute a donation, if possible. Thank you!

Consent and Waiver

I, the undersigned dancer or parent/guardian of the above named minor dancer consent to the dancer's participation in dance classes sponsored by the Glen Burnie Recreation Association, which are anticipated to take place from September 2026 to May 2027. As the dancer or parent/guardian of said minor child, I assume the risk of possible physical injury which may result from participating in said dance classes. Any claim on my behalf or on the behalf of the minor is hereby waived and released for any injuries resulting from participation in these dance classes to the full extent that such a release or waiver is allowed under the applicable laws of the State of Maryland.

Media Clause: I consent to the use of my/my child's photographic image/voice in any marketing/advertising materials created by G.B.R.A. Mediums may include but are not limited to brochures, posters, fliers, print ads, broadcast (TV/radio), web pages, or social media. I consent to the use of my child's unidentified physical image and/or talents in the case of broadcast (TV/radio/video) interviews or filming. I release any claim to or control over the photographs/vocal or visual talents regarding their production use of placement in said marketing materials.

Behavior Clause: It is understood and agreed that the dancer can be expelled or removed either temporarily or permanently from the program for behavior which disrupts or endangers the program or other dancers. This action shall be at the discretion of the teacher. Also, the program may set forth rules of conduct.

Participant Waiver, Release, Indemnification of All Claims and Covenant Not to Sue Agreement

NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. Read this document carefully and in its entirety. By signing this agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for any personal injury, however caused, arising out of your use of the Glen Burnie Recreation Association, the facility and associated equipment, now or at any time in the future.

I further intend the above representations are intended to be as broad and inclusive as permitted by Maryland Law. I further agree, for myself and any Successor, that should I or my Successors assert any claim in contravention of this Agreement, I or my Successors shall be liable for the expenses (including all attorney fees and costs) incurred by the other party or parties in defending against such claim, whether or not such injury is for the benefit of all Releasees, all and any of which shall be entitled to enforce this agreement against me. If any term or provision of this agreement is found invalid or unenforceable, the remaining terms and provisions of this agreement shall remain binding and enforceable.

I acknowledge that I am 18 years of age or older or the parent or the guardian of the above minor and that I am therefore of lawful age and otherwise legally competent to sign this agreement. I further understand the terms of this agreement are legally binding and certify that I am signing this agreement, after having carefully read it, of my own free will.
