The Glen Burnie Recreation Association will start its 66th year of dance classes beginning the week of September 20th. The program is open to anyone who is at least 3 years of age by September 1, 2021. Regular classes are one hour long and include ballet and tap instruction. Jazz instruction is included for those seven and older. Mail in registration is from now until September 1st. **Our preferred method of registration is mail in or drop off, in our secured locked mail box.** If you must register in person, walk-in registration is at the studio on September 8th from 6:00 pm to 8:00 pm. All information is subject to change. **Please know, only dancers and staff are allowed inside our building.**

This year's tuition for regular dance classes is **\$170** per student which reflects a discount for cash or check. Tuition is **\$175** per students using a credit card. The full amount for each student must accompany the registration form.

Tuition is non-refundable. No dancer will be placed in a class without payment. There will be a \$30 charge for returned checks. Checks should be made payable to GBRA. Classes must have a minimum of 6 dancers, if the minimum is not met classes may be reassigned.

Specialty class are being offered in addition to regular dance classes:

Pointe class (45 minutes) is offered for those 13 years of age and older with at least 3 years of ballet training. Pointe shoes are not to be purchased without approval of the instructor. Tuition is **\$100.00** (cash or check) or **\$105** (credit).

Pom classes (30 minutes) will be offered for 7-10 years old, middle school and high school/and above. Tuition is **\$90.00** (cash or check) or **\$95** (credit). Most Pom classes will require white tennis shoes, ages 7-10 years old are required to have white tennis shoes by picture day.

Hip Hop classes (30 minutes) will be offered for 9-10 years old, middle school and high school /and above. Tuition is **\$90.00** (cash or check) or **\$95** (credit). Black jazz shoes are required for Hip Hop classes.

Lyrical classes (30-45 minutes) may be offered for middle and above. Lyrical shoes may be required. Indicate interest on the registration form. Dancers will be contacted if we have a class.

General Information:

Each dancer **MUST** wear leotard and tights or leggings. No athletic shorts. All dancers need leather ballet shoes with elastic straps (pink for females and black for males) and black tap shoes. Dancers may bring their own water bottles; our water fountain will be turned off until further notice.

Only dancers and staff will be allowed inside the building. We will greet your dancers at the door. Dancers will enter in the front door (porch) and exit out of back door. When dropping off, wait for your child to enter the building before you leave. If she/he is late, come to the BACK door and ring bell. Please be prompt in bringing and picking up dancers. We encourage all dancers to use the bathroom BEFORE coming to class.

At this time, GBRA will determine closures due to weather or emergencies. Please call the studio after 2:30 p.m. at 410-768-1058 for information regarding closures.

Important COVID-19 Guidelines:

No one will enter the GBRA dance studio if experiencing any symptoms of COVID-19 or any other flu-like symptoms, including having a temperature. If your dancer has tested positive for COVID-19 in the past 14 days, please notify GBRA immediately and do not enter the studio. If your dancer has been exposed to any person who has tested positive for COVID-19 or who has exhibited symptoms of COVID-19 within the last 10 days please notify GBRA immediately and do not enter the studio. If your dancer becomes ill or has any symptoms during class, they will be removed from class and a parent will be contacted immediately. **Please keep your dancer home if they feel ill or have been around anyone ill.**

All dancers and staff will practice CDC recommended safety precautions and wash or sanitize their hands regularly. Masks will be required for all dancers, staff and parents following the recommendations of the CDC and or federal, state or local regulations, this may change in the future.

Recital Information:

There will be recitals in early May. Classes may be in more than one recital. Details to follow.
