The Glen Burnie Recreation Association will start its 68th year of dance classes beginning the week of September 18th. The program is open to anyone who is at least 3 years of age by September 1, 2023. Regular classes are one hour long and include ballet and tap instruction. Jazz instruction is included for those seven and older. Mail in registration is from now until August 30th. **Our preferred method of registration is mail in or drop off, in our secure locked mailbox on our front porch.** If you must register in person, walk-in registration is at the studio on Wednesday, August 30, 2023, from 6:00 pm to 8:00 pm. All information is subject to change. **Please know, only dancers and staff are allowed inside our building.**

This year's tuition for regular dance classes is **\$225** per student which reflects a discount for cash or check and includes our digital download of our recital. Tuition is **\$230** per student using a credit card. The full amount for each student must accompany the registration form. Tuition includes a digital download of our recitals.

**Tuition is non-refundable. No dancer will be placed in a class without payment. There will be a \$30 charge for returned checks. Checks should be made payable to GBRA. Classes must have a minimum of 6 dancers, if the minimum is not met classes may be reassigned.**

**Specialty classes are being offered in addition to regular dance classes:**

**Pointe class** (45 minutes) is offered for those 13 years of age and older with at least 3 years of ballet training. Pointe shoes are not to be purchased without the approval of the instructor. Tuition is **\$100.00** (cash or check) or **\$105** (credit).

**Pom classes** (30 minutes) will be offered for 7-10 years old, middle school and high school and above. Tuition is **\$100.00** (cash or check) or **\$105** (credit). Most Pom classes will require white tennis shoes, ages 7-10 years old are required to have white tennis shoes by picture day.

**Hip Hop classes** (30 minutes) will be offered for 9-10 years old, middle school and high school and above. Tuition is **\$100.00** (cash or check) or **\$105** (credit). Black jazz shoes are required for Hip Hop classes.

**Lyrical classes** (30 minutes) will be offered for those in High School and above. Tuition is **\$100.00** (cash or check) or **\$105** (credit). Lyrical shoes may need to be purchased for recital.

**General Information:**

Each dancer **MUST** wear leotard and tights or leggings. No athletic shorts. All dancers need leather ballet shoes with elastic straps (pink for females and black for males) and black tap shoes. Dancers may bring their own water bottles; our water fountain will be turned off until further notice. If your dancer becomes ill or has any symptoms during class, they will be removed from class and a parent will be contacted immediately. **Please keep your dancer home if they feel ill or have been around anyone ill.**

**Only dancers and staff will be allowed inside the building.** We will greet your dancers at the door. Dancers will enter in the front door (porch) and exit out of back door. When dropping off, wait for your child to enter the building before you leave. If they are late, come to the **BACK** door and ring the bell. Please be prompt in bringing and picking up dancers. We encourage all dancers to use the bathroom **BEFORE** coming to class.

**At this time, GBRA will determine closures due to weather or emergencies. Please call the studio after 2:30 p.m. at 410-768-1058 for information regarding closures.**

**Fundraiser's:** We need everyone to support to continue our dance program every year – see the calendar for all fundraisers and please make plans to attend and/or contribute a donation, if possible. Thank you!
