Face/Body Painting Disclaimer

Allergy/Health Information

Although the face paints used are nontoxic, hypoallergenic and FDA approved specifically for use on the skin, allergic reactions can still occur in rare cases. If there is a concern regarding skin sensitivity, please request a skin patch test BEFORE painting. For additional assurance, you may also request a listing of ingredients or products brand

In order to insure the safety of others, anyone with the following conditions will not be painted: open wounds, cold sores/ blisters, chicken pox, measles, mumps, cold or flu symptoms, conjunctivitis (pink eye), infectious skin conditions, contagions, eczema and other skin conditions, or appears unwell.

Pregnant women must be hydrated and able to stand or sit for extended period of time.

Maintenance of Supplies & Products

Paint brushes are cleaned before and after each event with mild hypoallergenic soap. Sponges are laundered at high temperature with hypoallergenic soap. Both sponges and brushes are allowed to air dry. It is not necessary for paints to be sterilized between or events as they possess antibacterial, anti-mold and anti-fungal properties, however, the surface of the paints are wiped with hypoallergenic baby wipes after each event/set.

Paint Removal

All paints used are water based and can be cleaned using soap and water. Torii Le'Chelle Creations LLC is not responsible for paints that are transferred to clothing and/or other materials, the model may come into contact with after the painting sessions.

A small scrub and verbal recommendations for soaps will be provided upon request.

Torii Le'Chelle Creations LLC is not responsible for any clogged sinks, drains or any other washing units that may be caused by the removal of paint, glitter, or any other body creation medium.

Conduct

Guest are not permitted unless given consent first. Models are expected to be fully or semi-nude and should prepare for vary temperates. Models have the right to deny completion of the painting session and should read the refund policy.
