AGENDA ITEMS

I. LEADERSHIP REPORTS

- a) FISD Admin's Report > Dahria Driskell
 - The 2024-2025 School Year launch has been smooth. There's been a reorg and lots of training. Facilitators are rising to meet the needs of our kiddos. We know have Elementary and Secondary Coordinators.
 - ii) TEA has reached out to 206 districts to participate in a funding pilot. They want to gather data on what services districts receive in an effort to determine what funding to fight for at January's State Legislature discussion. The last time it was changed was 1987.
 - iii) Dyslexia shifted in the State of Texas to Special Education. ARD Committee would have these discussions.
 - iv) Inclusive Playgrounds have shifted to the broader district. Architects are reviewing ways to expand in order to work with all students.
 - v) Oct 5th from 8am to 12pm Joint district Parent Expo scheduled for Pearland, Alvin and Friendswood. Multiple vendors in the cafeteria covering various topics including Behavior, Transition, Dyslexia, and more.
- b) President's Report > George James
 - i) George provided a handout with the Clear Creek monthly events. It's good to learn about events at other districts.
 - ii) We have restructured the Committees this year. We combined the Fundraising, Events and Volunteers into one committee called Fundraising and Events.
- c) Vice President's Report > Kristen Westerfield
 - i) Kristen began doing research on what Parent Liaisons do in other PTO organizations.
 - ii) Kristen gave us an overview of the FISD Cares presentation that took place recently
 - iii) Action: Kristen will reach out to the representative about speaking at one of our evening meetings.

 - i) We finalized our budget for 2024-2025 over the summer. We reviewed the budget during both meetings.
 - ii) Vote: Attendees voted to accept the Proposed Budget. There was discussion to vote later in the year to donate profit to areas that will directly help our Special Education programs and staff.

The goal for TEC is to help students with behavior in order for them to return to their home campus. TEC offers a safe space which is set up to resemble what students will do at their home campus.
