AGENDA ITEMS

- I. Leadership Reports
 - a) Special Guest FISD Superintendent Thad Roher
 - i) We discussed the upcoming 2025 Bond Election. The last Bond Election was held in 2020.
 - ii) For 2025, FISD brought in an Engineering and Architectural firm to come up with priorities. The plan is to revisit priorities every 5 years for the biggest needs. They invited 40 Community and Staff Members to join the advisory group. After weeks, this advisory group voted on the following bond propositions (165M+ Total):
 - (1) Consolidate Westwood and Bales to create one campus versus two. The plan would include collaborative teaching and learning spaces. The construction would start in Fall of 2026. The new campus would be built behind the current buildings which lessens the risk. By having one campus it's safer to have everyone under one roof. We would have dedicated STEM labs, Innovation Labs, Career Pathway Hubs, and more. As for Quest infrastructure, it will come with the design planning
 - (2) Build a new High School Agriculture Barn. The agriculture program consists of the strongest leadership instruction. There were 110 projects that were turned away due to insufficient space. They would build the new infrastructure behind Harbor Church. There are over 500+ students impacted. This program has grown tremendously over the year. For the old facility open air sheds, they would like to sell. Program in Agriculture are used for inclusion. There would be plans for the arena to host events. We could have our own Friendswood Show.
 - (3) UIL Extracurricular Upgrades. We do not have enough locker rooms. These upgrades would include renovating the current field house. It would include a new cheer gym with good ceiling height but also keeps the cheerleaders on campus. It would open the possibilities of using the old cheer shack for the Transition Center and TEC. The FISD Band would get a turf field to practice all weather space along with the drill team and soccer. It would also include mat room for wrestling.
 - (4) Inclusive Playgrounds which include playground upgrades for all elementary, intermediate, Junior High, High School. Transition center, and TEC. It would include shock absorbent and slip resistant padding to allow for easy movement for mobility devices, strollers, and crutches. There has been some work underway so work would start immediately.

- (5) The bond will also include an Innovation Space at Windsong.
- (6) The estimated tax increase is 16 cents with the exception of residents over 65 who have no tax rate. Early voting is October 20-31 and Election Day is Nov 4th
